## for Businesses and Residences

The City's Capital City Clean Up (CCCU) is teaming up with property owners to help you keep your property graffiti-free. With your support, more of Edmonton can shine.

### What's in the Kit?

The City has free graffiti clean up kits available to property owners to remove graffiti vandalism. Kits include painting supplies (paint roller, brush, paint tray, tray liner, scraper, gloves, painting rags, spray bottle, T-shirt) and 4 graffiti removal wipes. Kits also include a 25% discount coupon from Rona Home and Garden Centres to purchase paint.

### What do I need to do to get a kit?

Complete the application form and mail, fax or e-mail it to Capital City Clean Up along with:

- a photo of the graffiti vandalism
- your police incident file number

Once we have received your application form we will arrange for you to get your kit.
