Edmonton's Commercial Energy Audit Rebate Program encourages Edmonton's large building owners who participated in Edmonton's Building Energy Benchmarking Program, to "take the next step" to understand their energy use and act to improve their energy efficiency.

You will need to provide the following details for each building, to a maximum of three buildings:

- Has this building received an ASHRAE Level 2 energy audit since January 1, 2018?
- What date was the commercial energy audit completed (month, day, year)?

- What was the total cost for these services? This will be used to determine the rebate amount which is up to \$10,000 or a maximum of 50% of the audit cost, whichever is lower.
- Have you, or will you, receive another rebate for this energy audit? If yes, for what amount of money? (Note: The total cannot exceed 100% of the costs of the services)

All energy audit reports shared with the City of Edmonton will be kept confidential, however they will undergo data analysis, be used for program evaluation purposes and will inform the design of future Energy Transition Strategy projects focused on energy use in commercial buildings. programming and will not be shared with other City of Edmonton departments without the consent of the property owner.
