Re: Shack Dwellers in the Vicinity of the Grierson Street Dump:

Answering your letter of October the 4th, in reference to the above, I have had the list submitted to Dr. Orr by Mr. W.R. Graham examined by the Department and find that none of these cases are on married relief. I then took the matter up with Mr. Powell, in charge of the work of the Unemployment Relief Commission handling single men, and discussed the subject fully with him with the idea of effecting a solution by putting these men where they could be properly taken care of. He writes me as follows:--

"In accordance with your request of even "date I am submitting herewith a report on "the men reported upon by Health Inspector "Graham as living on the dump, with a few "comments upon such men as I know, or have "some record of. Names omitted where not "found on the Single Men's Relief records.

Aged slightly over 50. Has "Wife in Poland. In Canada since 1913. On "relief from 2-11-32 to 12-11-32, and from "1-3-33 to 29-7-33, at which time he was "passed "Fit" for Camp, following which he "stopped reporting for relief. He had been "getting "Meals Only" at the Old Immigration "Hall. According to our records he has no "relations in Canada.

There are one or two others who I cannot "fully identify, who were stated by Mr. Graham "to have been on relief, these are

"but enough of these men have been identified to "give me a very good idea of the situation as it "exists.

There are only about half a dozen of the "21 men who have been relief charges who are in "good standing at the present time, most of them "being "Cut Off" for refusing Camp or Farm Work. "The men who accepted a grub stake and have been "self-sustaining since then are eligible for "shipment to a camp when we have a camp order, and "one man, K , is actually in receipt of relief "at the present time, though I think he should be "receiving it through Drayton's office. Some men, "you will notice have a record of more than one "refusal of either farm or camp work, and it seems "only natural to expect that they would again "refuse camp, or quit a few days after being sent "there, as has already happened in some of the "other cases.

"in any way possible, and so am submitting the "following proposition subject to the approval of the "Unemployment Relief Commission, who will receive a "copy of this letter to-morrow. As you will "readily understand I cannot bind myself to do "anything which may not meet their approval, though "I am of the opinion that it will be regarded as "satisfactory

"of the men whom the City desire to be moved "could be instructed to report to me for "registration."

"they will be medically examined and if passed "as "Fit" will be sent to the Government "Employment Office, and from thence to a Camp.

"understand that failure to comply with these "requirements would mean no further relief from "the Commission, or any further consideration "from the City.

"them that they must stay at least 3 months in "such camp as they may be sent to, and at the "present time, as my instructions are that fit men "are to be cared for only in Camps there would be "no guarantee that they would again receive relief "if they quit at the end of that period.

Regarding those men who might be "passed as "Unfit", there would only be a few "of these, and I am suggesting that these might "properly be a charge on the City, as at the "present time the men are self-supporting and will "be deprived of a means of livelihood, even though "it is a precarious one, by the City's actions. I "think this should apply to K as well as the "others, and as there would only be a few, no "doubt the City could house them all in one of "their own houses.

"the foregoing proves to be acceptable, I would "like to have a few days notice in order that I "can get in touch with Mr. Patterson, of the "Government Employment Service, so as to have a "Camp Order ready for the men when they report, "and also, a few days time should be allowed so "that all the men could be notified and have no "excuse to the effect that they were not told or "did not know soon enough, and it would give the "City Health Department time to so notify them."

I thought from the foregoing that a settlement of the difficulty was established, but yesterday I received the following note from Mr. Powell, which leaves the matter still unsolved.

"I have been notified by Mr. Mackenzie "that he does not approve of my suggestion "to you re Grierson Dump, and he is not "willing that they be afforded an "opportunity to go to Camp."

I have not been talking to Mr. Mackenzie about this subject, but no doubt he takes the view that these men having refused their opportunity, are not now his responsibility.

If I am informed correctly, this particular situation does not cover the entire difficulty, as it appears that other men are digging in along the river bank within the boundaries of the City, and setting up a menace to good living conditions.

his own problem, and we find it difficult in the married cases to direct a man where and how he shall live. It is much easier for a single man to evade regulations and become a nuisance but if the conditions allowed to continue the system of relief suffers. The problem, however, is Mr. Mackenzies, and not ours, because if we allow a man to create domicile through residence in a hole in the ground or a tin shack, it is hard to say what the end of such a condition might be. It strikes me that a man having such a place of abode could not be said to have a home, but that he would still come under the qualification of a single homeless man. If this reasoning is correct then the Government should provide accommodation in the regular manner through meal and bed tickets, or else see that they do go to camp so that they will be living under safe and proper conditions.

We have no machinery now to take care of single men. I think we should strenuously oppose starting such a practice because it opens the way to questionable cases and would lead to our building up a system parallel to that which the Government has established, and which is supposed to take care of the entire problem.
