1. INTRODUCTION

The Edmonton Design Committee (EDC) was established by Edmonton City Council in 2005. EDC operates under City of Edmonton Bylaw 19784 with the mandate to "...improve the quality of Urban Design in the City of Edmonton".

2. POLICIES, PRINCIPLES AND PROCEDURES

The EDC operating under Bylaw 19784:

- Provides input to the City with respect to urban design principles, guidelines, and policies;
- Accepts submissions and provides recommendations to Urban Planning and Economy (UPE) on development permit applications, as required by Bylaw 19784, and on any other developments with potential design impact on the City, at the discretion of the City Manager or Council, within the established EDC boundaries;
- Accepts submissions and provide recommendations to Council on comprehensive rezoning applications, including Direct Control Provisions, Special Areas Zoning; and Major Commercial Corridor Overlays within the established EDC boundaries;
- Accepts submissions and provides recommendations to Council on comprehensive rezoning applications for Large Site Infill and Significant Transit Oriented Development;
- Reviews and provides recommendations on development applications, public projects or special projects in the City of Edmonton at the request of Council or the City Manager;
- Reviews Formal Applications and Informal Consultations and provides recommendations to the Applicant;
- Makes recommendations to Council as to changes to this bylaw; and

 Makes recommendations to Council as to changes to other existing bylaws and City policies relevant to urban design.

In addition to Bylaw 19784, the work of the Committee is also guided by EDC Standards and Procedures, which were developed through a collaboration of the Committee and City Administration.

EDC Principles of Urban Design

The EDC Principles of Urban Design express the aspirations of the Committee and facilitate a meaningful conversation with Applicants to support exemplary urban design in Edmonton. The three overarching principles relate to urbanism, design excellence, and scale, connections and context.

The Principles of Urban Design are intended to be reviewed by the EDC Subcommittee in 2023 (See also Attachment 2 / EDC Workplan).

Interacting with Applicants

The Committee interacts with Applicants in two main ways:

Formal Submissions generally coincide with Development Permit and Rezoning Applications. These are required of all projects which fall within the geographic boundary (See Figure 1), as well as for all City projects.

- Submissions are received by Administration and posted on the EDC website for public viewing and Committee review 10 days prior to the meeting date.
- The Applicant makes a 10 minute presentation to the Committee summarizing the project and its response to the Principles of Urban Design;
- Approved public speakers may make presentations to the Committee, and the Committee may ask questions of the speakers;



- Committee members may ask questions of the Applicant for clarification purposes;
- Following the presentation the Committee deliberates in public on the merits of the submission. The outcome of this deliberation is a recommendation of "support" or "non-support". This correspondence is forwarded to Administration and the Applicant within 48 hours.
 Correspondence regarding rezoning projects is appended to Council Reports prepared by Administration.

Formal presentations are also live streamed to the Edmonton Design Committee Youtube channel for public viewing.

Applicants can also opt for an **Informal Pre-consultation** prior to a Formal Submission. These presentations, which are not open to the public, allow an applicant to come to EDC for preliminary advice with respect to a development that is being considered. Because these presentations are not public, no written record of this portion of the meeting is kept.

In an Informal Pre-consultation, the Applicant and EDC can have an open dialogue, allowing Committee members to speak more informally, offer suggestions to improve the project, and clarify the principles and standards that will be expected during a Formal Submission.

In the opinion of the Committee, the Informal Pre-consultation process is extremely valuable. The conversations better prepare Applicants for Formal Submissions. Applicants who attend a Pre-consultation are typically more successful at gaining approval at the Formal Submission.

3. MEMBERSHIP

The EDC consists of up to twelve members appointed by City Council representing various design professions (APPI, APEGA, AALA) and the Edmonton Arts Council. The EDC also includes up to five public members:



three registered architects (AAA), a representative of the development industry, a representative of post-secondary institutions, and a member at large. The Committee currently has the following ten members (listed from most recently appointed to longest serving):

Melinda (Mindy) Tindall Public Member at Large 2022 - Current

Mindy is a passionately curious fourth-year architecture student with a background in nursing and healthcare. Her specialization is within healthcare, educational, landscape, and humanitarian architecture. She is working on her MBA in Innovation and Entrepreneurship and studying neuroscience and neurotechnology at Queen's University. Mindy has studied universal design at the University of Alberta, and recently graduated with her Renewable Energy Technologies Certificate. She has also obtained certifications in humanitarian design, renewable architecture, and ecological design.

Mindy is an experienced entrepreneur and has amalgamated her interests in these fields by founding Biotecture Inc. – a catalyst for wellness through design – which was featured in the 2022 summer cohort of Startup Edmonton's Student Founders Program. She recently served two terms as Chair of the Royal Architectural Institute of Canada's Edmonton Network. She is passionate about innovative health-oriented design and looks forward to her second term on the Edmonton Design Committee.

Neal Lamontagne Post-Secondary Faculty Member 2022 - Current

Neal is a registered city planner and academic focused on policy planning and urban design. He is a full time faculty lecturer at the University of Alberta School of Urban and Regional Planning and a PhD candidate at UCLA focused



on design review and governance. Prior to returning to Alberta, Neal worked as a planner in San Diego, San Francisco and Metro Vancouver and taught planning and design at the NewSchool of Architecture and Design, UC San Diego, Langara College, UBC School of Community and Regional Planning and School of Architecture and Landscape Architecture and the SFU City Program. He is a former co-chair of the Vancouver City Planning Commission and vice-chair of the Vancouver Urban Design Panel.

Neal currently sits on the EDC Subcommittee.

Nick Pryce

Alberta Professional Planners Institute (APPI)

2021 - Current

Nick is a Registered Professional Planner (RPP) with over 30 years of planning, engagement, and facilitation experience across Canada and internationally. In his career he has been involved in many aspects of developing policy and regulatory planning documents. Nick has also been at the forefront of training Councils and Administrations on planning in Alberta. In carrying out planning projects, Nick has been extensively involved with the engagement and communication with a focus to help people to understand the importance of planning documents and to get the public more involved. To achieve this requires a range of tools to reach out to people and a process that provides time to inform people on the topic of what the document is, how it works, and why it is important for members of the community to participate in the process. 4. ACTIVITIES

Meetings and Presentations

Presently, EDC meets on the first and third Tuesday of each month, typically reviewing two to four applications at each meeting. Periodically, an extra meeting will be scheduled to review applications in a timely manner and reduce any backlog. Additional time is required by Committee members to review the development packages prior to the meeting.

During the 2022-23 term, EDC reviewed **22** Formal Submissions (compared to 35 in the previous term). Of these submissions:

- **18** received a motion of support (81%)
- **4** received a motion of non-support (18%)


The Committee also reviewed 8 Informal Pre-Consultations.

Over the course of the term, EDC met **14 times** with the average meeting being approximately **3.0 hours** in duration (compared to 3.5 hours in the previous term and 4.0 hours in the 2020-2021 term).

ATTACHMENT 2 / WORK PLAN

Implementing New EDC Standards and Procedures

Outside of the regular activities of the Committee, through 2022 the Committee focused on assisting Administration with the implementation of the new EDC Standards and Procedures, which were approved by the City Manager on December 3, 2021.

A Work Plan for 2022-23 and Beyond

In late 2022 a Subcommittee was struck to formalize a new work plan to be initiated during the remainder of the 2022-2023 term. This workplan focuses on four key activities:

1. Improved Onboarding / Training Tools

Ensuring new EDC Members receive sufficient training has consistently been identified as a priority of the Committee. The Subcommittee will lead this activity, with input from the Committee and the support of Administration as needed. This is a high priority activity with the intent to be completed to coincide with the introduction of new Committee Members in May 2023.

2. Reviewing the EDC Principles of Urban Design

Reviewing the EDC Principles of Urban Design was identified as a key concern of the design and development industry during the 2021 Standards and Procedures project; however, due to resource and timing constraints, reviewing the principles was not possible at that time.

The Subcommittee will collaborate with Administration on this activity, with input from the Committee as well as the design and development industry (see below). The primary objective of this exercise is threefold:

- To better align the Principles with the policy objectives of The City Plan and other City plans and standards (e.g. Complete Streets)
- To ensure the Principles are focused on those considerations of greatest importance to the Committee at the present time.
- To ensure the Principles are tailored to the specific requirements of both Development Permit and Rezoning submissions.

This is a high priority activity intended to commence in Spring 2023; however, continued resource constraints may limit the ability of the Subcommittee to significantly advance this work this year.

3. Industry Engagement

Administration committed to a followup with the design and development industry to evaluate the effectiveness of the new EDC Standards and Procedures. At the same time, the review of the EDC Principles of Urban Design will necessitate engagement with external stakeholders. The Subcommittee will support Administration, who intend to initiate this activity in Spring 2023.

4. Councillor Luncheon

Prior to COVID-19, EDC hosted an annual luncheon with the Mayor and City Councillors. The purpose of the luncheon was twofold - to provide an informal setting for the Mayor and City Councillors to meet EDC Members and learn more about the work of the Committee, and at the same time recognize outgoing Committee members. The Subcommittee will collaborate with Administration to host the first Councillor Luncheon since 2019 in Fall 2023, prior to the Edmonton Design Awards Gala.

Notes

- (1) Approved operating budget representing the 12 month period beginning January 1, 2022.
- (2) Committee Members receive a \$100.00 honorarium per meeting, with the Chair receiving \$125.00. For meetings that exceed 5.0 hours in duration, members receive a \$200.00 honorarium. Value is based on full member attendance, maximum meeting duration (e.g. >5.0 hours), allowance for additional meetings due to volume of applications, training, etc.
- (3) Lower costs reflect a number of Committee vacancies and shorter meetings than in previous years..
- (4) Catering for meetings.
- (5) No catering was needed as all meetings in 2022 were held virtually.
- (6) To courier printed submission packages to Committee members.
- (7) No courier services were needed as all packages were submitted electronically.
