• The Applicant is encouraged to utilize canopies or similar elements to introduce human scale and provide weather protection to the streetscape. Weather protection should be provided in accordance with Capital City Downtown Policy 12.11, which requires "...the provision of properly designed overhead weather

protection on key pedestrian shopping streets in the form of canopies, awnings, sunshade overhangs and colonnades to improve the year-round sidewalk shopping conditions and ensure pedestrians are protected from falling snow and ice." (Note that 101 Street is classified as a pedestrian shopping street).

- Reconsider the location and / or treatment (including lighting and weather protection) of the Automated Teller Machine to improve user comfort and safety.
- Encourage the Applicant to revisit the detailing of the metal panel assembly to reduce the number of joints and seams to accentuate vertical patterns in the facade and improve its overall visual appearance.

While the Committee generally supports the proposed built form, the Committee has a number of concerns related to the public realm that requires the Applicant to return to the Committee with a comprehensive landscape plan which:

- Defines streetscape / public realm components (surfaces, furnishings, features, landscape) and arrangements that better supports and accentuates ground floor commercial, apartment entry and the corner
- Clearly indicates the intended design within private property, and clarifies the private-public interface, in particular along the southern frontage
- Confirms the property line along the back alley

The Committee also notes the following:

- Confirm and provide details of the screening/landscape of surface level parking at the southeast corner
- The articulation and materiality of the south facade could be extended to the east facade to bring greater consistency to the building and improve its overall visual appearance

The Applicant is encouraged to return to the Committee once additional conversations have taken place, and required agreements are in place, with the appropriate City departments.
