# C COMMITTEE DELIBERATION

C.1. 10-Unit QM Project (Development Permit) Eric Lobo - Wolf Development

MOTION: A. Benoit

Motion of Non-Support

While the Committee is supportive of the overall concept for this project, a number of critical design elements and considerations have not been adequately resolved (see below). As a result, the project requires considerable design refinement, and in doing so, the Applicant is encouraged to review and respond to the EDC Principles of Urban Design.

- Key details are missing and / or lack refinement; eg. garbage enclosure, railing, etc.
- Inconsistency between drawings (eg. elevations and renders, civil and landscape plans).
- Exterior materials discussed at the presentation (eg. residential vinyl siding) deviate from the submitted package and are not consistent with the architectural expression of the building as described by the Applicant.
- Incorporation of electrical and mechanical systems have not been adequately addressed. If rooftop or exterior mechanical units are proposed, consideration of how these units will be integrated and / or screened is needed to minimize their visual impact on the streetscape.
- Secure, internal bike parking should be considered.
- Consider widening sidewalks, and incorporating signage or other architectural features to identify and direct visitors to side and rear entries.
- Consider modifying the landscape treatment along the north elevation; eg. replacing mulch with landscaping or another treatment that is more appropriate and welcoming for the side entries and more consistent with what is proposed for the south elevation.
- Placement of windows on each side facade will need to respond to the adjacent buildings, eg. to reduce overlook.

# The Committee also notes that the project could have benefitted from an Informal Pre-consultation.
