<ul> <li>3.1 Equitable Recreation Programming Audit</li> <li>The Office of the City Auditor conducted an Equitable Recreation Programming Audit in June 2024. The report identified that the Community Recreation and Culture Branch needs an effective approach to planning and providing equitable recreation programming for all Edmontonians. The report made four recommendations: <ul> <li>Recommendation 1:Improve information gathering on recreation programming needs to identify access barriers and inform equitable program planning. (by March 31, 2025)</li> <li>Recommendation 2: Develop and implement an integrated plan to support equitable recreation programming. (by March 31, 2026)</li> <li>Recommendation 3: Develop equity objectives for each major programming area to assess effectiveness and identify areas for improvement. (by June 30, 2026)</li> <li>Recommendation 4: Develop documented guidance for staff to ensure equitable, inclusive, and accessible recreation programming. (by September 30, 2026)</li> </ul> </li> </ul>	Recommendation #1 is currently being worked on. Recommendation #2 is starting to be worked on. This work will integrate and align with Policy C602. Looking to host focused conversations and pop ups to reach equity seeking target groups. Committed to finishing the research by March 2026, but may require an extension.
The staff leading recommendation 2 would like to share with you a bit about the work, and get some preliminary input on the vision for the integrated plan for equity.

4.4.1. Update on Edmonton Transit Services - Transit Centre Curb Painting Initiative	discuss accessible parking. The Policy Committee will share a letter to advise Council for more accessible parking. D.Rudolph met with CoE staff and CNIB representatives at WestMount Transit Centre to review the difficulties/concerns with the blue paint of the piloted curb changes. The blue colour is not differentiable for those with vision loss/blindness. There is a heightened risk of injuries.
	ETS to use the current yellow paint scheme. Possibility of another pilot (at another terminal that is already yellow) using three foot black wide stripes (which is also the International Hazard symbol). Another suggestion would be to use the same glitter that is currently used in crosswalks to improve night visibility. This is a two year project. D. Rudolph and CNIB continue to work with ETS.
