Safety Code Inspection Booking Improvements

In 2022 the Safety Code Inspections team switched to a capacity-based booking platform to increase predictability of inspection service timelines. We heard that a drawback to this system was that you were not always able to request multiple inspections for a job site to all be inspected on the same day.

Upcoming New Alberta Codes Editions

Alberta Municipal Affairs has published a notice indicating that the new National Building Code - 2022 Alberta Edition, the National Fire Code - 2022 Alberta Edition and the National Energy Code for Buildings (NECB) 2020 will come into force in the spring 2024. National Plumbing Code of Canada - Transition Period

The National Plumbing Code of Canada 2020 (NPC 2020) came into force on April 1, 2023 and is applicable throughout the province of Alberta. There will be a 6-month grace period given to enforcement within the City of Edmonton. **Learn more**.
