District Planning: Read the What We Heard Report!

Red Tape Reduction and Service Improvements

Planning and Development Fees 2023-2026

Planning and Development fees for 2023-2026, which include land development and subdivision applications as well as development, building and trade permits, are now live for the new year! The proposed fee schedule has been simplified with the consolidation of 105 fee items, saving applicants and the City time spent on applications. Safety Codes & Permit Updates

Professional Work Product Authentication for Sole Proprietors

To assist the City of Edmonton in verifying full authentication and validation of professional work products without delays, we ask that a sole proprietor clearly indicate that status by placing the words "Sole Proprietor" in the vicinity of the authentication stamp in lieu of the permit to practice validation. This will allow for quick identification of sole proprietors and avoid unnecessary delays and questions due to the absence of permit to practice information. **Read more**.

Construction Site Safety

As we welcome winter and the accessibility challenges that come with it, we would like to take this opportunity to refresh the requirements for safe access and guardrails on construction sites. Sites require a safe method of entry, with handrails or ramps meeting OH&S standards. Throughout the site we require handrails on stairs over five risers, handrails or walls on both sides of stairs and all openings to be properly blocked with a guardrail. **Review the example guide**.

Building near Overhead Power Lines

The City of Edmonton and EPCOR Power have been working together to provide guidance on developments adjacent to overhead powerlines. While this guidance is being finalized, please be reminded that the Alberta Electrical Utility Code (the Code) requires workers to meet or exceed minimum clearance requirements when both working and developing within the proximity of a powerline. It is up to applicants to ensure that they are meeting the requirements of the Code. EPCOR's **brochure** provides more details on the Code, which can be referenced when making an application on a lot that is adjacent to an overhead powerline.

Please review the clearance requirements and reach out to EPCOR should you have any further questions. The City of Edmonton and EPCOR will continue to refine educational material and

the application process to help ensure development adjacent to overhead powerlines complies with the Code requirements. For more information on overhead line clearance, contact EPCOR at **ces@epcor.com**.

Construction Site Addressing

The City of Edmonton requires that all job addresses be posted clearly for both safety and accuracy as this ensures quick emergency response times and efficient inspections. In the residential sector while the site is in the footing stage, a sandwich-board style sign is acceptable with the caveat that as soon as you have a wall built you will attach a sign for the duration of the project. In the commercial sector this may be more of a challenge prior to windows being installed, but we will accept any method that clearly marks the address and eliminates confusion while aligning with the safety requirements. **Read the guidelines**.

EPOCR Interconnection Process Change for 2023

As part of a 2023 process improvement by EPCOR and The Inspections Group, please ensure that your interconnection agreement is in place prior to connection into the utility grid. In the coming weeks inspectors will be asking for a copy of the fully executed interconnection agreement to allow for final connection. The process will have a soft start, and will begin pass/fails when an interconnection agreement is not present during inspection effective Monday, March 6, 2023.

This process change is to help prevent any solar installers from accidentally connecting to the grid and causing any potential harm to the public and/or damages to utility infrastructure. This change also helps align processes for interconnection. There will be ongoing communication from the City, The Inspections Group and EPCOR in the coming months about this change.
