Reminder: Builder Education Program Training Dates Open for Registration

The next round of courses for the Builder Education Program, which qualifies you for the Expedited Infill Review Process, are being offered from June 22 to June 29, 2022. This pilot is in partnership with the Infill Development in Edmonton Association. To register, visit the IDEA Certification Program website.

After completing the Builder Education Program offered by IDEA, participants will have access to 21 calendar day review timelines for specific infill development permit applications through an Expedited Infill Review Process. Development and Construction Application Processing Times Now Available

Processing times are now available for most development and construction-related service applications. Processing times are measured in calendar days from when a customer submits a complete application to when a decision is made.

These timelines are a starting point to help build a more transparent, consistent, and predictable experience for our industry partners so they can plan their construction projects accordingly. The next step is for the City to continue implementing process and technological adjustments through the Permit and Licensing Improvement (PLI) initiative, regulatory changes through the Zoning Bylaw Renewal initiative, as well as resource reallocation to improve consistency and further reduce application processing timelines where possible. Red Tape Roundtables Update

The City of Edmonton continues to work and engage with small and medium-sized enterprises and businesses to identify and prioritise permit and licence service improvements. Since 2017 when significant improvement projects were initiated and implemented, the City has met, surveyed and engaged on many needs identified by a diverse industry and business base. Overall, the system of permits and licence services has continued to improve incrementally with different industries recognizing and benefitting from those improvements. Read more.

Preparation For Ground Plate Inspections

In an effort to improve the outcome of inspections for ground plates, the City, EPCOR, and Inspections Group have come up with a new method for builders and contractors to prepare for ground plate inspections. This is a temporary method until further notice. There will be a new method in the near future.

Install the ground plate inside the basement as normal, 600mm below the finished grade (basement floor). Then vertically install a 4 inch PVC pipe approximately 6 to 12 inches long directly over the ground plate at the connection point of the wire to the ground plate. You may then cover the rest of the ground plate, making sure the inspector can see the connection. If the PVC fills with water, the inspector will deal with it.

Land Development Application Fee Changes

As of June 1, 2022, the advertising fee associated with land development applications has been replaced by a notification and engagement fee with no change to the amount. The fee is generated when the application is accepted for processing, and the applicant is expected to pay the fee before the file can be processed. The change is being made to cover both the costs of public engagement and to continue advertising in the Edmonton Journal.

Reminder: APEGA Authentication and Validation Update

In November 2020, APEGA enacted the Authenticating Professional Work Products practice standard, which addresses "standardization of authentication and validation formats to enable licensed professionals, permit holders, and the public to easily identify the authenticator and the validator, as well as the dates of authentication and validation."

Substantive revisions have been made to this practice standard, which provide further clarity on the requirements for validating professional work products. This revised practice standard is effective and enforceable as of January 1, 2022.

Professional members are reminded to follow the current guidelines presented in the Authenticating Professional Work Products practice standard when submitting permit applications. Going forward, the City will be monitoring submissions and may reject documentation if the 2022 standard is not followed correctly.
