Additional Rebate Funds Announced for Solar Program

In response to heightened demand for the Change Homes for Climate Solar Program, the City of Edmonton is providing additional rebate funds for installing solar PV systems on homes and multi-family buildings. Solar industry installers and consultants are encouraged to let their clients know to apply as soon as possible to reserve their solar PV system rebate as funds are limited.

The Change Homes for Climate Solar Program launched in July 2019, providing rebate incentives for installing residential solar PV systems in Edmonton over three years. In June 2021, the City of Edmonton added funding to meet program demand during the COVID-19 pandemic. The program has supported over 490 residential solar PV systems in Edmonton with an estimated local renewable energy capacity of 3.9 megawatts since the program's launch.

In addition, your clients may be eligible for the Canada Greener Homes Grant, which offers up to \$5,000 in rebates to homeowners for installing solar PV systems and complements the Change Homes for Climate Solar Program.

Home Improvement Permit Customer Experience Survey

Over the next three months the City will be giving all contractors and homeowners that apply for home improvement permits an opportunity to share their experience. Surveys wil via automated email right after a home improvement permit is issued and again after the final inspection is complete.

This pilot survey is part of the City's work to improve customer service and experience under the **Permit and Licensing Improvement (PLI) Initiative**. Part of this work involves collect and incorporate feedback from applicants on an ongoing and timely basis and using it to help identify and drive red tape reduction and continuous improvement opportunil

At the end of the pilot, the project team will review the results and evaluate how best to incorporate customer satisfaction surveys into our day-to-day operations long-term, includ permit and licensing services.

Inspection Requesting

The City of Edmonton has made improvements to the way Safety Codes inspections are requested. The transition to capacity-based inspection requests for all disciplines (buildin and electrical) is now complete.

Previously, inspections could be requested on any business day even though the day may have been full. In contrast, the new system allows a permit holder to request an inspect available inspection capacity. Once capacity has been reached, the calendar will show the day as unavailable and another day will need to be selected. Underground Conduit Installations for New Services

The City of Edmonton is aware of the supply chain issues for obtaining 2.5 inch (63mm) conduit for new service installations. For the time being, 2 inch or 3 inch rigid PVC condu installations, and you can go back to direct buried cable if unable to get conduit.

Permitting for Lightning Protection Installations

A Standata has been jointly developed between the Building Discipline and Electrical Discipline for lightning protection. Starting April 2022, lightning protection falls under the Ele permit and inspections are required for all installations of lightning protection systems. Review the Standata.

In April 2022, Alberta Municipal Affairs released revised schedules of professional involvement authorized under Standata Building Code Variance 19-BCV-024. Read more.

Updated Guidelines for Establishing Security for Servicing Agreements

The City has made some revisions to the guidelines for establishing security for servicing agreements. Separate guidelines have been created for servicing agreements security a development permit versus required as a condition of a subdivision. Also, the extra security requirements for projects, which have delayed engineering drawing approvals for C B developers, have been reduced.

Building Permits and Inspections Processing Times Dashboard

It's peak construction season, and the City is currently experiencing a high volume of building and trade permit applications and application status inquiries. Industry professional can reference the **building permit and inspections processing time dashboard** to see when building permit applications will be assigned for review and when requests for building permit be scheduled.

Please note that processing time estimates on the dashboard apply to building permit applications and inspections only. For development permit application status updates, pleas 311 (780-442-5311 outside Edmonton).

The City is in the process of updating the dashboard to display processing timelines for most permit application and inspection types and hopes to have this information availabl

Reminder: In-person Permit and Licence Inquiry Appointments Now Available

With Provincial health restrictions lifted, the City is now offering in-person permit and business licence inquiry meetings at the second-floor Service Centre in the Edmonton Towe **appointment only** on Tuesdays, Wednesdays and Thursdays. Virtual permit inquiry appointments also still remain available on Tuesdays through Thursdays.

The way the development industry interacts with the City is changing, and we are offering services that align with customer expectations. This, coupled with changing public heal provided an opportunity to adapt service offerings and maximize resources.

The move to appointment-only services at the Service Centre allows for our industry customers to better plan their day with a specific appointment time as well as for more efficie resources to serve those customers. Industry members are encouraged to consider continuing to use online application services and phone, email and virtual appointment inq service needs.
