Curbside Management Strategy

The Urban Planning Committee endorsed the Curbside Management Strategy on August 23, 2022 (see item 7.4). The next step is for the City to develop implementation plans for each of the strategy's seven actions. Implementation will be gradual, with actions taking about five to seven years to complete depending on Council priorities and funding.

Actions 1, 2 and 3 will be prioritized first. Opportunities for development industry engagement and input will be assessed as part of the forthcoming implementation plans.

Safety Codes & Permit Updates



New Approved Ground Plates

A.C. Dandy has just had a new type of ground plate CSA approved, and the City of Edmonton intends to accept their installation. If you are installing these new ground plates as per the **installation guidelines**, then no inspection of the ground plates will be required. However, the approval label on the upper portion of the rod must be visible at the time of the service inspection. Inspections of other grounding electrodes will still be required. A.C. Dandy is working to have these ground plates delivered to suppliers as soon as possible.
