Effective December 31, 2020, the City will be changing its process for calculating the 10 minute fire response time boundaries required under the Alberta Building Code. All building permit applications accepted after December 31, 2020 will be subject to the new response time boundaries, as outlined in the new 10-minute response time map on maps.edmonton.ca/map.aspx under ERD Public Data > Outside 10 Minute Boundary in the map legend.
