To reach our goal of carbon neutral new construction in Edmonton by 2030, we all need to work together. That's why the the focus of the series for 2020 will be on emissions neutral buildings, including:

- reducing the energy loads on our buildings (passive design, wall design, wall construction techniques, air barrier installation techniques, etc.),
- increasing the efficiency of building systems (HVAC, lighting, etc.), and
- adding renewable energy such as PV to offset the remaining energy.

The first session will provide an introduction to the monthly series, an opportunity to provide feedback on the proposed themes for 2020, as well as suggestions for topics that will provide the greatest benefit to grow the knowledge of the design and construction community.

Sessions will be aimed at practical applications rather than theory. Speakers throughout the year will include City staff, builders, design professionals, manufacturers, and other industry experts.

## **Open Option Parking Goes to City Council Public Hearing**



On June 23, 2020, City Administration will be bringing a report to City Council Public Hearing recommending the **implementation of Open Option Parking (item 3.22)**. Open Option Parking will remove minimum on-site parking requirements from the Zoning Bylaw, allowing

homeowners and businesses to decide how much on-site parking to provide based on their particular operations, activities or lifestyle.

The Public Hearing is an important part of the engagement process for Zoning Bylaw changes. Industry members have an opportunity to provide feedback on the move to Open Option Parking with Council by **requesting to speak** at the June 23, 2020 Public Hearing. If approved by Council, the proposed changes will take effect on July 2, 2020.
