The City of Edmonton has expanded its online permit services to support permit revision requests for commercial and new house construction projects. If a proposed development changes following issuance of a permit, the permit must be revised. Common types of revisions include truss/joist layouts changes, elevation and layout changes, or changes in engineering.

As part of Action 9 on the City's Infill Roadmap - "Better inform residents on how they can effectively participate in the planning process", the Infill Liaison Team reviewed more than 150 infill documents and web materials, assessing their relevance and effectiveness in communicating the infill development process to community members and residents.

The first of many changes involved moving information from the City's infill website to the City's main site (edmonton.ca) and reducing redundancies and centralizing information. Working in alignment with the City's Urban Form Business Transformation and Customer Oriented Website Enhancement projects, information was organized to best leverage the current user experiences of builders, homeowners, and next-door neighbours, making it easier to find information about housing redevelopment.
