Making it Easier to Correct Trade Permit Deficiencies

In the spring of 2020, the City expanded the use of Verification of Compliance (VOC) as an option for re-inspection of corrected building or trade permit deficiencies identified from an earlier inspection. This method involves providing a self-declaration and photographic supporting evidence that verifies the deficiencies from the previous inspection have been rectified.

Electrical inspection reports already indicate when a job is VOC eligible. The City will now be expanding these eligibility notes to plumbing and gas inspection reports to help further streamline the deficiency correction process.

If a plumbing and gas inspection report contains a "VOC eligible" note, the contractor can reach out to the City's tech desk to request a VOC form to verify the noted deficiencies have been corrected. The contractor can then proceed without needing another in person inspection for that portion of the job.

VOC is not available for life safety deficiencies or initial safety code inspections of any type. Stay tuned for further VOC process updates.

Detached Garage and Accessory Building Foundation Requirements

With the recent implementation of automated garage permits, the City would like to take the opportunity to remind builders and their contractors about the Code requirements for detached garage and accessory building foundations. Detached garages and accessory buildings that are 55 square metres or greater, or support a second storey and/or a roof-top deck, must be supported on a Code-compliant footing and frost wall or engineered foundation. For those under 55 square metres, a concrete slab may be used as a foundation/ floor combination in most instances. Learn more.

Garage Electrical Receptacle Requirement Changes

Effective October 1, 2021, any electrical receptacles in garages that are 30 amps or greater will require a load calculation unless there is an energy management system installed with the receptacle. This requirement is being introduced due to these receptacles increasingly being used for car chargers, which can affect the demand load on the main breaker in a home. Questions?
