





This subdivision was originally approved on February 10, 2022. The first Change Request was approved on December 7, 2023. It swapped phases 2 and 3, and re-lotted the row housing along the east side of Kinglet Boulevard, resulting in one less lot. This second Change Request switches the order of phasing, alters the phasing boundary and creates 7 additional lots.
