Spearey also reminded the Subcommittee that a motion of support means that a project generally meets the criteria and has no significant design changes, while a motion of non-support would mean that there have been significant design changes. **Info.**
 - J. Mills suggested that prompts be added to the Chair script to help the Chair guide the Committee when the recommendations in a motion are becoming extensive (i.e. there are a significant number of bullet points identifying conditions). **Action:** Admin to update
