

You are invited to apply for your 2024 ETS Subsidized Senior Annual Pass. The 2024 annual pass is valid from January 1 to December 31, 2024.

The cost of the Subsidized Senior Annual Pass is dependent on your personal income. If your income is below \$33,579 you are eligible for one of the two reduced price options listed below. To receive your subsidized pass, you will be required to provide proof of income, proof of age and proof of address.

The New Way to Pay for Transit

Arc, the Edmonton region's new electronic fare payment system, is a convenient and flexible way to pay for transit.

All senior fare riders, including monthly and annual pass holders, will transition to Arc in 2024. ETS can assist you with this process.

Seniors who purchase ETS Subsidized Senior Annual Passes will no longer receive an ETS paper or plastic pass. ETS will provide seniors with Arc cards preloaded with the reduced price annual pass.

Once you receive your Arc card in the mail, you can start using it. You will tap your Arc card on the fare validator when you get on the bus or enter the proof of payment area in an LRT station and you will tap your card again when you exit the bus or proof of payment area at an LRT station.

If you travel with Dedicated Accessible Transit Service (DATS), you will be required to show your Arc card to the Operator when you board. You will not be required to tap on and off DATS vehicles until the vehicles are equipped with the Arc handheld fare validators later this year.

You will not pay more for transit service in Edmonton with Arc than what you currently pay for an ETS Senior Annual Pass.

Proof of Income

A copy of ONE of the following must be included to be eligible for Tier 1 or Tier 2.

- 2023 T4A (OAS) (if box 21, net supplement paid, shows any amount above zero).
- Guaranteed Income Supplement (GIS) letter of eligibility from the Government of Canada.
- 2022 Notice of Assessment (line 15000, gross individual income must be below \$33,579).
- Permanent Resident or a refugee document (to qualify, you must have been in Canada less than one year and have not filed a tax return).
- Proof of government Employment Insurance (EI) being received in the past three months.
- Health Benefits Card within the last three months showing receipt of Income Support benefits.
- Canada Pension Plan T4A(P) Form for the 2023 tax year showing credits for Disability Benefit.

Proof of Age

A copy of ONE of the following must be included to be eligible for Tier 1 or Tier 2.

- Driver's licence
- Alberta Government identification card
- Alberta Health Care card
- Permanent Resident card

Proof of Address

A copy of ONE of the following must be included to be eligible for Tier 1 or Tier 2.

- Driver's licence
- Documentation with your name and an Edmonton address (e.g., bank statement, utility bill or phone bill)
