The Committee welcomes this proposed development; however, the Committee believes that the project is over-programmed and as a result there is limited opportunity for performative ecological infrastructure or social connectivity with the surrounding context. The Committee recommends that the Applicant take the opportunity to assess and consider the following to address these concerns:

- A1 Enhanced integration and connectivity with surrounding built form and natural features.
- A2 & A3 Respecting and/or utilizing surrounding natural areas/open space to establish a more holistically sensory environment for staff and visitors to the site.
- B1 Opportunities for high-albedo and/or permeable paving surfaces compliant with City of Edmonton maintenance standards.
- B1 Opportunities for ecological (Low Impact Development) applications to address stormwater management and mitigate urban heat island effect.
- C1 Providing additional connectivity for building users to access the surrounding natural areas, and providing additional amenity for users of the trail system.
