• Consider the further design refinement (form/function) of the north and east edges of the park to enhance activation; create increased access and use in all seasons; enhance connectivity between park corners and Michael Phair Park; and address safety/CPTED issues (actual and perceived) to eliminate pinch points, and enhance visibility.

- Further explore the activation of the "Jasper Avenue Plaza" area to invite a strong relationship to the urban fabric of Jasper Avenue.
- Refine the lighting design with attention to both placemaking quality and illumination levels to enhance safety.
