C.2 Affordable Housing Initiative- Garneau (DP)

The Committee welcomes this proposed development, and in the interest of ensuring a high standard of urban design recommends the Applicant:

- Consider the landscape precedent image examples provided in the design submission and the selection and application of proposed fencing for bicycle storage and the north outdoor amenity space that provides a more "residential" quality.
- Review and refine the proposed planting design along the 83 Avenue edge of the north outdoor amenity space that provides open visibility between the building/amenity space and street.
- Consider the landscape precedent image examples provided in the design submission and assess opportunities to replace some of the proposed bench seating in north outdoor amenity space with fixed tables and chairs that support opportunities for residents to gather and socialize - or - sit alone.

The Committee welcomes this proposed development, and in the interest of ensuring a high standard of urban design recommends the Applicant:

- Consider limiting chain link fence to more utilitarian portions of the site while incorporating alternate decorative fencing in housing areas to to establish a more "residential" essence and aesthetic.
- Reassess the proposed planting plan and plant quantities to establish a more functional, safe, and visually/physically open "backyard" space, and apply for a variance to reduce the minimum landscape requirements in the Zoning Bylaw.
- Consider adjusting the location of the Donation Centre immediately east of the playground to establish a buffer between the housing/"backyard" space and proposed parking lot, removing the need to fence in the playground and integrating this amenity with the "backyard".
- Consider incorporating therapeutic/healing opportunities into the "backyard" space, such as gardens or walking paths.
