#### C.2 107 Avenue Public Park

Madeleine Mussieux- City of Edmonton

Motion of non-support: J. Mills Seconded: N. LaMontagne

While the Committee supports this development in principle, there are a number of items that require significant review and refinement:

- Creating a cohesive design language for the park through the application of forms, materials, colours, and furnishings. The current design presents a range of different forms, patterns, materials, and architectural styles. (Principle C1)
- Ensuring that pedestrian circulation around the site considers access design standards. New street furniture, paving, etc. should not impede a clear, consistent path for pedestrians walking along 107 avenue (includes consistent width of walkway i.e. not becoming narrower in certain areas or introducing obstacles that impede a clear pathway). Ensure there is an accessible connection to the raised stage from within the park. (Principle C3)
- Considering sensory conditions created with adding landscape islands along the
  northwest edges of the park. These visually and physically impede sight lines and
  clear lines of movement along and through the park. Consideration should be
  given to incorporating the spaces on the west side of the site into the functional
  program area, and eliminating the raised planters to enhance the interconnectivity
  of spaces and enhance visibility and accessibility. Opportunities to integrate the
  existing LRT cabinet into the site should be investigated. (Principle A2/A3;
  Principle B1/B3)

- Reviewing the proposed landscape buffer along the south edge of the park as proposed, the buffer provides little visual/auditory screening from the apartments and day-to-day or special events in the park. Consider integrating coniferous trees (e.g., pine) that provide canopy space and provide a buffer. (Principle A2/C1)
- Consider increasing the scale of the overhead shelter to provide additional
  weather protected space with seating/tables beneath. The current design does not
  provide a lot of utility to the park. The location of the shading structure should
  also be located so as to optimally provide shading in the summer months.
  (Principle B3)
