The Committee recommends that the Applicant:

- Give due consideration to the relationship of the building to the surrounding neighbourhood and streetscape context, as manifested in the public realm interface (e.g., surface treatment, landscape, site furniture, features and lighting).
- Give additional consideration to the colour palette and material use on side facades the Committee recommends matching white material to leave possibility for future public art, being mindful of material transitions.
- Consider relocating the rear bicycle racks adjacent to the back of the building to enhance movement & circulation.
- Direct additional attention to defining building entrances through the use of signage, lighting, and material configuration.

In addition to the above, the Committee notes that a landscape and lighting plan was not included in the package submission and the Committee recommends Administration work with the Applicant to finalize these items.
