

# Accepted Identification for Special Ballots



## When applying for special ballot

To be eligible to apply for a special ballot package, you must be registered on the permanent electors register.

If you are on the permanent electors register prior to applying for a special ballot, you are not required to provide identification when submitting your application.

When applying to be added to the permanent electors register as part of your special ballot application, you must provide identification that proves **your name and current residential address**.

Choose from one of these options:

1. One piece of government-issued identification that contains your photograph, name and current address. PO boxes can be accepted on your **Alberta Driver's Licence** or your **Alberta Identification Card**.
2. One piece of **authorized identification** that establishes **your name and current address**.

## As part of your special ballot package

When completing your special ballot package, you must include a copy of **one piece of authorized identification** that establishes **your name and current address** in the outer return envelope.
