# October 2024 Biennial Employee Experience Survey

This report summarizes what we heard from Financial and Corporate Services employees for the October 2024 Biennial Employee Experience Survey.

**925** employees (78%) participated and there were **1,217** comments.

This biennial survey provided employees with an opportunity to share about their identity, experiences of inclusion, respectful workplace, concerning behaviour and discrimination at work, and their overall experience working at the City of Edmonton.

## Consent to Disclose Identity Information

The following 5 slides contain topics about sensitive information (identity and experiences of concerning behaviours and discrimination).

Respondents were given the opportunity to opt out of these voluntary questions if they **did not** consent to the City of Edmonton and Glint processing their responses.

823 (89%) 925 of Financial and Corporate Services employees who participated in the survey consented to collection of this sensitive data.

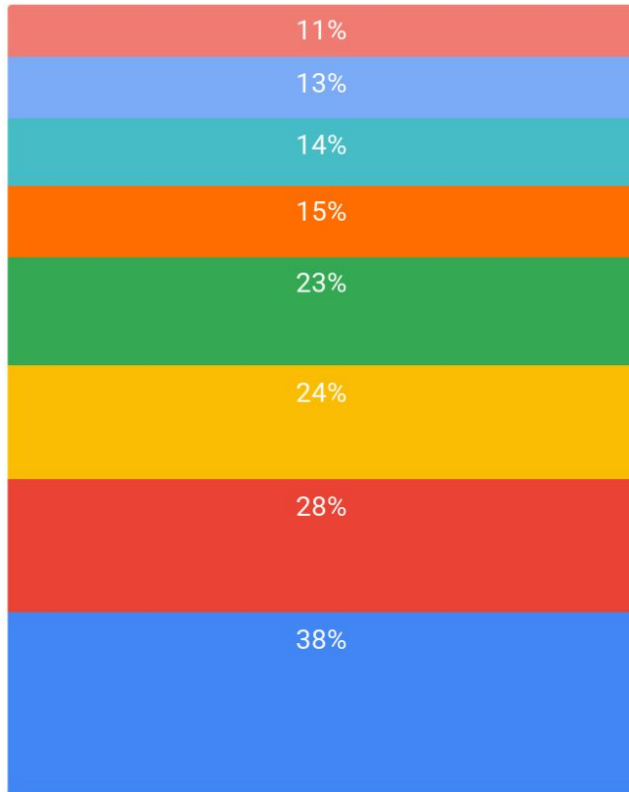
## Respectful Workplace: Discrimination Results

Select all that apply.

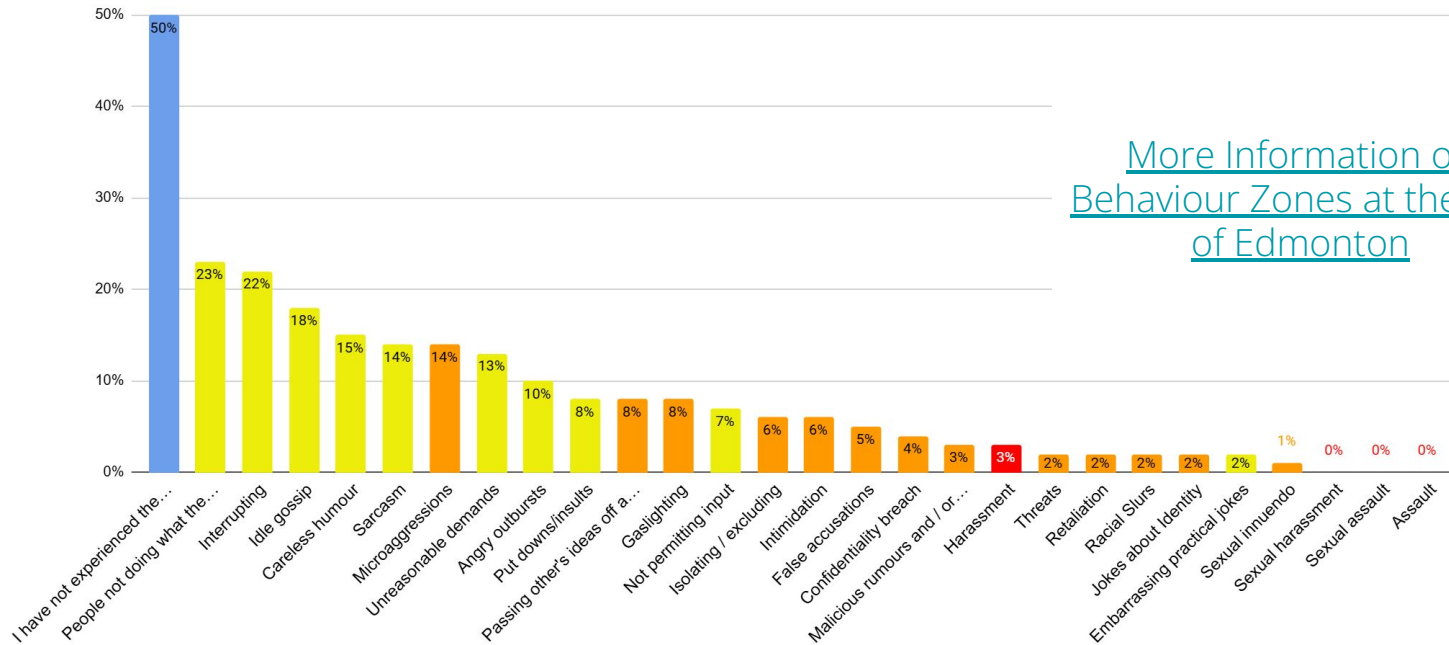

## Most significant changes from 2022:

- 4% decrease of employees who reported experiencing concerning behaviours
- 10% increase in people not doing what they said they would do, interrupting and having unreasonable demands
