## Neighbourhood Renewal designs are taking shape – Share your thoughts!

Since September 2020, the City has been preparing for Neighbourhood Renewal by studying your walking and biking routes, streets, intersections and parks and by reviewing public feedback to learn what is important to those who live, work and gather in the neighbourhoods.

Proposed design ideas and options to improve roads, sidewalks, pedestrian crossings, bike and walking connections and City-owned parks and open spaces in Boyle Street and McCauley are now ready for your review and feedback.

These proposed designs could change how you use your streets as roads will need to be reshaped to fit in new elements like wider sidewalks, trees, bike lanes, public gathering spaces or one-ways.

Please take time to review the renewal ideas and design options, consider the benefits and tradeoffs of each and how they may affect you. Provide your feedback by **September 30, 2021**. No design decisions have been made and the Project Team looks forward to your input.

Construction is scheduled to begin in 2023!

## **City projects**

What other City projects are happening that affect your neighbourhood?

#### 40 km/h Speed Limit

The speed limit is now 40 km/h on most residential and downtown streets. Reducing speed limits on these streets and high pedestrian areas makes our streets safer, calmer and quieter for everyone.

#### **Water Bottle Filling Stations**

A few fire hydrant locations in Edmonton have been selected for modification with water bottle filling stations. One of the hydrants is located in McCauley just east of Giovanni Caboto Park on 94 Street.



Latta Bridge (Jasper Avenue northeast of 91 Street and southwest of 90 Street )

The Latta Bridge is scheduled for a full replacement with construction to start in 2022. Please visit the project webpage for more details edmonton.ca/projects\_plans/roads/latta-bridge

#### Street Lab

A new City of Edmonton program, Vision Zero Street Labs (more information available at this link edmonton.ca/StreetLabs), launched earlier this year that aims to create safer streets. This program creates an opportunity to trial temporary community-led solutions on Edmonton streets by combining the expertise and power of Edmontonians and City of Edmonton staff to creatively address neighbourhood safety and livability concerns. Each Street Lab is tailored to the unique needs of the community. A Vision Zero Street Lab application was received for Boyle Street, which involves the installation of temporary curb extensions to narrow the southbound driving lane on

95 Street at 103 Ave. This measure will also create a safer crossing area for pedestrians by shortening the crossing distance on 95 Street. This work is independent of the work that is currently being led for the neighbourhood renewal that is planned for the Boyle Street neighbourhood.

However, during the public engagement work for the Boyle Street neighbourhood, there were a number of safety and livability concerns that were raised. For this reason, the City is planning to use temporary traffic calming measures to trial some of the design options that the Building Great Neighbourhoods team has been working on based on the feedback from the community. Planning for this will happen over the winter months with installation planned for Spring 2022. Stay tuned!

#### Alley Renewal (residential alleys)

Residential alleys in Boyle Street and McCauley are in the queue for the 2023 – 2026 budget cycle and will not be included in neighbourhood renewal.



### Street lights and sidewalks - You decide

Local Improvement options during Neighbourhood Renewal

#### What is a Local Improvement?

A Local Improvement is a construction project undertaken near or next to residents' properties which is considered more beneficial to the property owner and local area than to the City as a whole. Local Improvements are part of the Neighbourhood Renewal discussions with you and your neighbours.

#### How is Neighbourhood Renewal paid for?

The Neighbourhood Renewal Program is paid for through a City-wide property tax reserve fund dedicated to the program. However, two specific improvements-decorative street lights and sidewalk reconstruction-are cost-shared by the City and property owners in the neighbourhood, as they are considered a Local Improvement.

#### **Decorative streetlight options**

Through the Local Improvement process, the community will **DECIDE** on the kind of lighting that will be installed during renewal. Information about the process, styles and possible costs will be shared in the coming months.

#### Sidewalk reconstruction

A sidewalk reconstruction is initiated by the City as part of Neighbourhood Renewal. As a property owner, you will be able to **DECIDE** on whether you would like to proceed with sidewalk reconstruction or not. Information about cost-sharing with the City on sidewalk reconstruction and the process to provide your feedback will be shared in the coming months.

### Neighbourhood Renewal funding

Funding for the Neighbourhood Renewal program has come through a combination of City–wide property taxes and provincial funding over the past decade. To be approved for construction, the cost for the design must fall within the renewal budget for the neighbourhood. Some elements proposed may not receive funding, however efforts will be made to partner with other City programs and initiatives to leverage additional funding opportunities.

Boyle Street and McCauley have waited for renewal. The upgrades we are currently designing are to support the communities now and for the next 30–35 years in the future. The Neighbourhood Renewal Program has been recognized as being the most cost effective way to add missing infrastructure into an area as significant construction work is already underway.



### Next steps Community Feedback on Draft Design

#### November 2021 to February 2022

Guided by public engagement, technical data, research and analysis, the Project Team will create a draft design that shows how the proposed changes for walking, biking, rolling, driving and playing in Boyle Street and McCauley will work together to provide the best neighbourhood experience for all users, balancing the needs of today and into the future.
