This report summarizes what we heard from Parks and Roads employees for the September 2022 Biennial Employee Experience Survey.

526 employees (32%) participated and there were 464 comments.

This biennial survey provided employees with an opportunity to share about their identity, experiences of inclusion, respectful workplace, concerning behaviour and discrimination at work, and their overall experience working at the City of Edmonton.

14% of Parks and Roads employees who participated in the survey **did not consent** to collection of this sensitive data.


