INTRODUCTION: PROJECT OVERVIEW

The City of Edmonton is launching a new Pop-up Dog Park Program in spring 2023, installing up to 30 temporary dog parks in neighbourhoods identified as having a high need for an off-leash area. These neighbourhoods were selected based on their proximity to existing off-leash areas, guidelines in the [Dogs in Open Spaces Strategy](#), the number of licensed dogs and requests that City Councillors and Administration have received since 2016. Potential locations within these neighbourhoods were selected based on the availability of unused or underutilized green space and took into consideration other factors such as zoning, adjacent land uses and setbacks, fit within the overall park site, ability to be serviced by operations crews, accessibility factors like the terrain, proximity to paved trails and sidewalks with curb cuts to access them, lighting, sight-lines, availability of active transportation options and parking and presence of foot/vehicle traffic.

During Phase 1, the City gathered insights from external and internal stakeholders and residents to help understand residents' preferences for the proposed Pop-up Dog Park locations. An online survey was available for residents in neighbourhoods where the installation of Pop-up Dog Parks was proposed.

Locations proposed during Phase 1 engagement were evaluated and finalized based on the feedback received from residents and technical/operational considerations. Installation of the selected Pop-up Dog Parks will begin in May. All selected sites located in the same park as a playground, splash pad, sports fields, or adjacent to an environmentally sensitive area or arterial road, will be fully or partially fenced. These amenities will be operational until November, weather permitting. Once the sites are installed, a survey will be available to capture the lived experience of the dog park users and non-users. At the end of the Pop-up Dog Park season, Administration will evaluate all the technical data and feedback gathered throughout the program to make final recommendations for ongoing off-leash areas.

Public Engagement Approach

The City of Edmonton's public engagement spectrum defines the public's level of influence in engagement processes. **The role of the public during this engagement was at the ADVISE level on the City of Edmonton's Public Engagement Spectrum** and the public was invited to share their feedback and perspectives on the proposed locations. How We Engaged

Online engagement opportunities were provided to broaden outreach and ensure a diversity of voices in the engagement process. An open link online survey was available from March 6-27, 2023 targeted toward residents in [37 neighbourhoods](#)¹ where the installation of a Pop-up Dog Park was proposed. The survey was open to all members of the public, however, the neighbourhood of residency was used to screen responses for a targeted analysis of the results.

Information about how to participate in the survey was communicated through the following:

- Mailer to 142,000 residents living near the proposed [Pop-up Dog Park locations](#) with the website address and QR code linking to the survey
- Signs strategically placed within the proposed neighbourhoods
- Social media posts about the pilot and how to participate in the survey (City of Edmonton Facebook, Instagram and Twitter)

The survey received over 6,561 responses.

Who Was Engaged

Administration gathered insights from external and internal stakeholders and residents to help understand residents' preferences for the proposed Pop-up Dog Park locations.

- All residents of the proposed locations and neighbouring communities (a group of neighbourhoods that would be served by the proposed pop-up dog park) were invited to share their feedback through an online survey.
- Feedback was collected from Community Leagues and Homeowner Associations about the existing recreational uses and prior community need assessments.
- Internal and external stakeholders including utility companies, were consulted for any concerns or conflicts with other projects or planned land use.

What We Asked

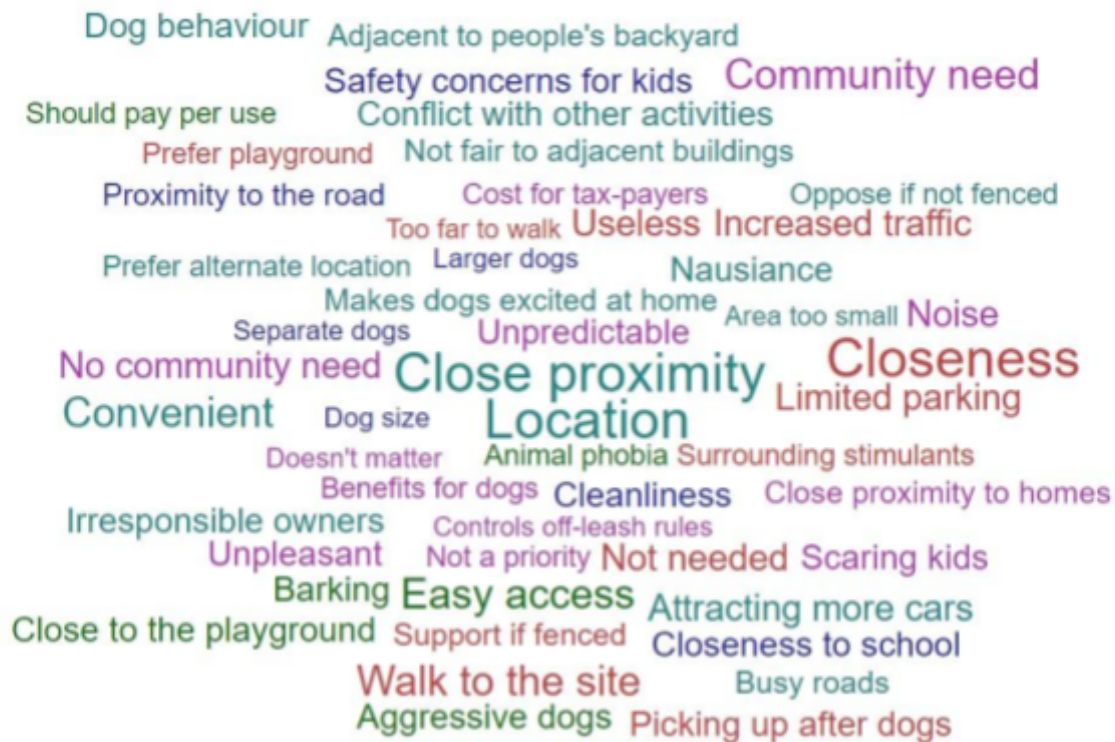
The goal of the survey was to understand the perceptions and attitudes of residents on the proposed locations, including the overall support level for having a Pop-up Dog Park in the neighbourhood and support for each of the proposed sites (if more than one site was proposed). Additional input was gathered about concerns, the current need for the dog parks, the likelihood of using the dog park and travel modes to access the potential locations.

To ensure diversity of responses from residents, Administration considered the proximity of the proposed locations whether adjacent, within one block, within 15 minutes of walking distance and more than 15 minutes from the proposed site. Although the varying perspectives of respondents living in close proximity were taken into account, the decision not to publish those detailed results in this report was made due to privacy concerns.

WHAT WE HEARD

Summary

- In general, opinions about the Pop-up Dog Parks were divided between residents that support or oppose the pilot. Of the 6,561 submitted responses for all 37 neighbourhoods, 59.3 per cent strongly/somewhat supported the idea of having a dog park in their neighbourhoods and 35.7 per cent strongly/somewhat opposed it.
- Respondents shared 3,976 comments about their support or opposition to the proposed sites and locations. Comments were coded and themed for further analysis. The main themes of support were: proposed locations, fulfilling the community's need for a dog park, convenient walking distance to the park, benefits to dogs, support for fencing, acknowledging the control of off-leash rules in dog parks and advocating for separation based on dog size.
- Respondents in favour of having a dog park in their neighbourhood think that given the number of dogs in their neighbourhood and the proximity of the closest off-leash parks, a Pop-up Dog Park is a community need.
- Respondents who did not support Pop-up Dog Parks were concerned about potential conflicts between different leisure activities within green spaces. Fencing, cleanliness and the unpredictability of the dogs were some of the other concerns, especially for families with children and people with allergies or dog phobias.
- Living in close proximity to the proposed locations was a major concern for some people as the presence and sounds of dogs in a Pop-up Dog Park could potentially be a constant nuisance during the day and stimulation for the dogs in the home.
- Other respondents did not support or oppose a Pop-up Dog Park in their neighbourhood for several reasons including not owning a dog, living far from proposed locations and the absence of small dog-only areas.
- The majority of respondents shared that they would walk to the dog park.

Detailed Findings

Public feedback was analyzed by neighbourhood and also by the specific location(s) within each neighbourhood where a Pop-up Dog Park was proposed. Some neighbourhoods had one proposed location while others had two to four locations. Also, there were neighbourhoods in close proximity that shared locations. Key findings for each neighbourhood(s) are summarized below.

GBA+ Spotlight

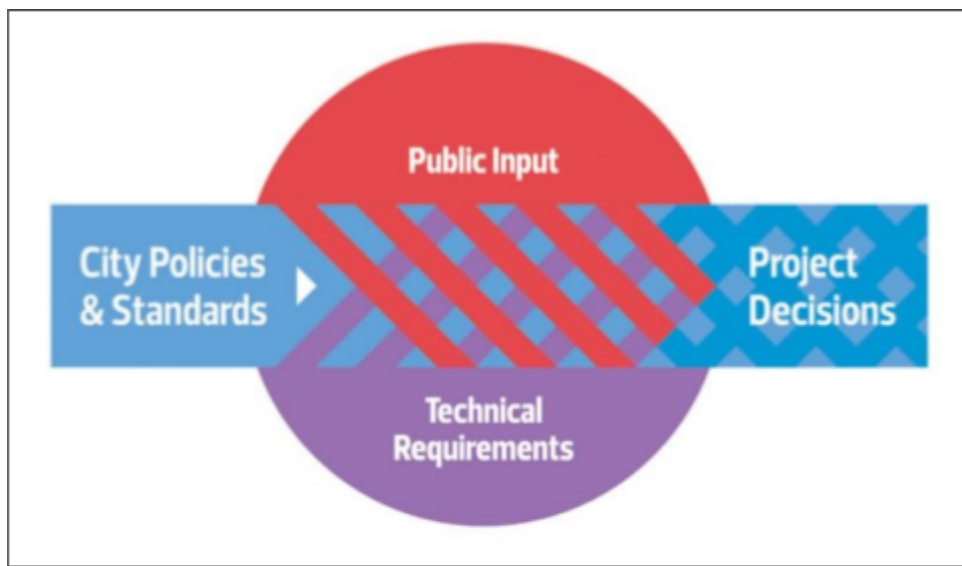

DECISION-MAKING

The Pop-up Dog Park Program takes into consideration a variety of inputs, including technical requirements and feasibility assessment, City policies and procedures, and thoughts and perspectives from public engagement at Phase 1 to select the Pop-up Dog Park locations for the installation at Phase 2. Individual Pop-up Dog Park locations will be announced on the [Pop-Up Dog Park Program](#) web page in May 2023. The installation will begin in May and locations will be operational until November, weather permitting.



Decision-making process

Over the course of the trial period, a survey will be available for residents and park users to provide feedback on individual locations as well as the Pop-up Dog Park program as a whole. Based on the results of public feedback collected during the six-month trial period and site evaluations, technical and operational feasibility and City priorities and programs, some or all of the Pop-up Dog Parks locations may be recommended to transition into ongoing off-leash areas with standard amenities including signage, dog waste bag dispensers, garbage cans and clear boundaries. If significant site enhancements are required such as fencing, trails or lighting, a funding request would need to be brought forward to City Council.
