## **B.** NEW BUSINESS

#### B.1 2024-25 Work Plan Update

- Draft What We Heard Report
  - P. Spearey informed the Subcommittee that the WWH Report is nearly complete, and is currently being reviewed by the internal communications team. The report will be posted to the EDC website next week.
- Work Plan Action Items
  - D. Brown disagrees with the comment that an increase in informal submissions (with a potential decrease in formal submissions) would result in less opportunity for public involvement with EDC. P. Spearey reminded the Subcommittee that in order for a project to be eligible for an exemption from the formal presentation, it would have to be presented to the public.
  - J. Mills confirmed that if the Applicant elects to present in public, the PDF submission should be posted publicly on the EDC website after the meeting. Action: Administration to follow up with OCC regarding this potential procedure.
  - D. Brown suggested that time should be added to allow the public an opportunity to review and comment on projects that are being exempted from the formal presentation. Action: Administration to follow up with OCC regarding this potential procedure.
  - The Subcommittee supports making the education and background of members publicly available. J. Mills suggested using the background information that each member provides to Civic Agencies upon appointment to EDC for this purpose.

• The Subcommittee discussed the structure of questions at the formal stage, and whether or not that should be adjusted for projects that have not come for an informal (i.e. rather than asking only questions of clarification, having more of an open dialogue with the applicant, similar to the types of questions that are generally asked at the informal stage)? D. Brown agreed that it is difficult being limited to questions of clarification for a project that did not come for an informal presentation, and that it would be helpful to clarify that projects which do not come for an informal presentation may be subject to more than just clarification questions (ie design opinions) during their formal presentation. J. Mills agreed, and added that this would help new members better understand what types of questions they should be asking. Action: Administration will update Section 3.4.6 of the Standards and Procedures as needed.
