Q4 2023 Trip Record Reminder

The Q4 2023 trip records will be due to the City by January 16th, 2024. Please ensure to use the correct templates as provided in our December 20th letter. If your company requires any clarification or assistance, please don't hesitate to reach out to our team for support. We expect to share insights from aggregated trip records in future newsletters.

Fee and Fare Review Project

The Vehicle for Hire team has initiated a comprehensive review of Vehicle for Hire fees and fares. It is one of the team's priorities on the 2023/2024 Council approved Work Plan and is in response to concerns raised by stakeholders regarding the costs and changing economic landscape impacting both industry and passengers. The Vehicle for Hire team is seeking services from a specialized consultant to lead this review and we expect that the contract will be awarded in January. Engagement with vehicle for hire stakeholders, including the industry and advocacy groups will be a critical part of this work. We expect to share the successful consultant and engagement opportunities in early 2024.

Driver Training Update

On June 13th, 2023 Council directed Administration to expand Vehicle for Hire training requirements to all drivers. We are working with NorQuest College to develop training content which will be handed over to the industry to deliver to their drivers. Effective April 2025, completion of training requirements will be a condition of new licenses and license renewals for all vehicle for hire drivers. A pre-engagement meeting is set for January 9th, 2024 between 1:30 pm. and 2:30 p.m. An email was sent out to dispatchers on December 11th, 2023 with additional information on industry engagement opportunities in January. Please refer to the email for details on the meetings and how to sign up. If you didn't receive the email, please reach out to our team.

Accessibility at Roger's Place

The City of Edmonton has received an increased number of complaints regarding accessibility at Roger's Place. As a reminder, dedicated pick-up and drop-off locations for accessible vehicles at Rogers Place are located on the east (102 Street) and south (104 Ave) sides of the building. ENFORCEMENT UPDATE

Enforcement Inspections

The Vehicle for Hire Enforcement Team has provided data on inspections and enforcement action conducted from January 2023 to November 2023. The first two sets of data show the number of inspections per month and the number of inspections by the business type. The number of inspections grew at the year end due to the Enforcement Team filling vacant positions.
