A.4. ENGAGEMENT DISCUSSION

K. Smith provided an overview of the Tall Buildings Design Guidelines & Urban Design Guiding Principles project and options for engaging EDC during the pre-consultation phase. At this time, Administration is proposing:

- 2 workshop sessions with the EDC, one for the Guiding Principles and one for the Tall Building Design Guidelines.
- At these sessions the project team would be on hand to engage with EDC members and provide more time for each member to provide their input.
- In contrast to the standard format, this alternate format would allow for more candid conversation, the open sharing of ideas and possible solutions, and a more robust discussion of the topics at hand. This will provide the team with a deeper understanding of EDC members' points of view.
- Materials would be provided in advance for review by EDC as per the standard process.
- Workshops would take place on a regularly scheduled EDC meeting date. It is estimated the workshops would be about 1hr in length, and be held in an adjoining room to ensure minimal disruption to the regular EDC agenda presentation.

The Committee feels the architectural language of the submission is disjointed and does not reflect the level of resolution or detailing expected of a formal submission to the Edmonton Design Committee.

While the Committee commends the Applicant for introducing a number of innovative program elements and design gestures, considerable architectural resolution and detailing is required to yield a more integrated, singular and refined design expression that responds to the varying context (street, alley and park). These program elements and design gestures include:

- Ground floor retail
- Parkade screening
- Glass stairwell
- Public art
- Use of colour
- Photovoltaic panels
- Rooftop residential units
