Motion of non-support.

- The project represents the introduction of a suburban typology into an urban environment with little response to the specific conditions of the site.
- West and south facades lack animation, contributing little to the increasingly urban condition of the site.
- Landscape requirements within parking lot have not been met.
- Configuration of site parking requires refinement.
- Lack of adequate pedestrian access / circulation to the building, from all directions (including through the parking area from adjacent buildings).
- Submission is incomplete, lacking materials board and illustrative lighting plan.
