- Revise the massing of the tower and increase its articulation particularly in its northern portion to reduce its monolithic nature, to better reflect the intent illustrated in the precedent images provided in the package.
- Reduce the diameter of columns along the arcade, or remove all together, to improve the quality of this space.
- Ensure that the screening of the above grade parking continues to conform to item 8.a.v in the DC text.
- Improve the north facade of podium, including the introduction of higher quality materials that are more continuous with other building facades.

- Ensure the DC text includes and references key appendices, including building elevations and a landscape plan.
- Include in the DC text regulations which ensure both the tower and podium are sufficiently articulated to reduced their perceived mass. As appropriate, include regulations which encourage the use of materials sensitive to the architectural context of the project.
- Include in the DC text regulations that strongly encourage the incorporation of colours and materials, as well as exploration of other design techniques, to reinforce winter city design principles.

- Improve the public interface of the building with Capitol Boulevard. The Applicant should select materials which not only acknowledge but complement and potentially extend the palette of Capitol Boulevard. Furthermore, the Applicant should explore animating and activating this interface with furnishings and other amenities.
- Provide universal access at the northeast corner of the building to ground floor commercial and the main building entrance.
- Strengthen the street wall along Capitol Boulevard by increasing the height of the podium to a minimum of two storeys between the existing and new structures.
- Clarify the selection of materials for rooftop patios (both above the first storey podium and at the top of building).
- Ensure that the materials utilized for the underside of balconies is as denoted in submitted package.
