REPORT FROM THE CHAIR, JASON PISESKY

As Chair of our AAC, I am proud to report the many accomplishments that our dedicated and diverse members have achieved in the past two years.

Since joining the AAC as our official City Council liaison, City Councillor Andrew Knack has been a valuable component of the AAC. He has provided guidance on upcoming discussions and reports going before City Council which may affect citizens with disabilities. He also provides guidance on how best to tackle certain issues and topics. He has been vocal in motivating us to appear before City Council. Our hope is to continue to grow this relationship in the coming months and years. In particular, Councillor Knack was instrumental in allowing the AAC to operate during the beginning of the Covid-19 pandemic. He served the administrative function that was left empty when City Council voted to cease offering administrative support to boards and committees. He connected us with city administration and made sure we had the latest issues before us to consider and work on.

Over the past two years, we undertook many projects that helped to position Edmonton as a leader in accessibility and inclusivity. Our hardest challenge was staying focused, due to the large and diverse number of issues encountered by people with disabilities.

Even before the passage of Policy C602 "Accessibility for People with Disabilities", the AAC was noticing an increase in requests for our time. In light of the looming changes to the City's accessibility

policies (culminating with the passing of Policy C602 in fall 2019), one of the more recent big changes to the AAC has been the piloting of a new Subcommittee: the Intake Subcommittee .

The goal of this new subcommittee was to help filter requests and meet with interested stakeholders, to hear their issues and determine and define our relationship with them going forward. The Intake Subcommittee experiment was a success, as it allowed us to meet with many more people and it had the "inflow" of work go through a larger and more diverse set of members. I am happy to report that the Intake Subcommittee had moved from a pilot to an official Subcommittee and we hope it allows the AAC to meet the needs of disabled Edmontonians for years to come.

Outside of structural changes, our efforts have focused on a few key areas over the past two years. Policy C602 was a big focus throughout 2019. Going forward, we hope to be involved in the development of department planning to include accessibility, and we feel our new structure will allow us to be involved on an even greater number of projects than we have been in the past. In contrast, perhaps unsurprisingly, 2020 was dominated by the pandemic and its impact on disabled Edmontonians. Despite the fact that we lost administrative support in early 2020, the AAC decided to continue operating as best as possible, which allowed us to work on issues related to masks, reopening and service delivery.



Over the past two years the AAC has also put considerable time into transit issues in the city. collaborated with ETSAB and DATS on many issues, including: LRT trains, bus network redesign, Smart Pass, signage, accessible taxis, and DATS issues. Accessible housing has also been a focus of the AAC, with a pilot subcommittee being experimented with to network with City administration and stakeholders. The AAC's goal is to change the conversation from "affordable housing" alone, to "accessible and affordable housing".

The AAC put a lot of energy into hosting our second annual National Accessibility Awareness Week in 2019, which included accessible home tours, a presentation from Amazing Race Canada contestants Lowell and Julie Taylor, a performance by a Fringe alumna, Carlyn Rhamey, on what life is like with ADHD and the Mayor's Awards. It was a highlight of the year to have all of City Council attend the Mayor's Awards, even if only briefly, and to have Mayor Iveson say a few words at the event named in his honour.

At a meeting in late 2019 the AAC voted to move the Mayor's Awards to the Protocol Office, to be melded together with the City of Edmonton's Salute to Excellence and Youth Council awards into the Edmonton Awards. We will continue to work with the Protocol Office to ensure the accessibility piece of their event meets our high standards. We are excited about combining the accessibility awards with non-accessibility awards for a truly inclusive award event. Unfortunately, due to the covid-19 pandemic, the 2020 Edmonton Awards was cancelled. The state of the

event in 2021 is still undetermined. Hosting events to engage our communities is a big part of the AAC's role in Edmonton, but we were limited in this capacity in 2020. Going into 2021, we are trying to determine the best way to keep engaged and hit the ground running once restrictions are lifted in the future.

As Chair, I am proud and humbled at the rich perspective our members bring to our Committee work and how with each of them, their number one goal is to help ensure that the City of Edmonton becomes a place that excels at inclusion for all. I hope you enjoy learning more about the work our AAC has done by reading the following annual report for 2019 and 2020!



MANDATE AND ROLE OF THE ACCESSIBILITY ADVISORY COMMITTEE

As an advisory body to Edmonton City Council, the AAC seeks to understand the unique accessibility and inclusivity needs of the Edmonton community, and how these needs relate to City Council's strategy and policy direction. The AAC undertakes a significant role in helping City Council address the manner in which its strategies and policies impact people with disabilities and provides advice on best practices for engaging Edmontonians with disabilities.

To undertake its mandate in the area of providing policy advice to City Council and City Administration, the AAC has identified the following as priority areas:

- 1. Advise** City Council and City Administration on policies, potential policies, or changes to existing policies that affect access and inclusion for persons with disabilities.
- 2. Participate in and support events** and opportunities that enhance overall awareness of inclusion and accessibility issues in Edmonton.
- 3. Engage** with broader communities of persons with disabilities in a meaningful way, and ensure that the AAC has the necessary information to undertake its advisory role.
- 4. Educate City Council, City Administration and the public** on issues and best practices around inclusion and accessibility.






Overview of the 2019 accomplishments:

- Presented an Accessible Taxi Report to Community and Public Services Committee, AAC will continue to work with City Administration on our initiatives (training, centralized dispatch and incentives)
- Met with the Presidents of the Greater Edmonton Taxi Alliance and United Taxi Group to learn about the driver perspective and concerns around accessible taxis
- Presented a Snow and Ice Control report to (C409) Community and Public Services Committee
- Worked with City Administration on designing a pilot program to assist disabled Edmontonians with Snow Removal
- Met with Peter Ohm, Chief City Planner to discuss accessible design in infrastructure and development both historically and prospectively. We look forward to working with him in the future as Policy C602 gets integrated into the City's administration
- Met with David Flannigan, Supervisor, Safety Codes Permits and Inspections to discuss the balance between Building Codes and Enforcement
- Contributed to the DATS report: Principles of Services for DATS — Contracted Service, Pickup Time and Impact of Snow and Ice Policy (CR_6537)
- Met with Charles Kelly, Vice-Chair of ETSAB to discuss collaboration and transit communication
- Contributed to the Bus Network Redesign, First Kilometre/Last Kilometre and new transit service standards and effective methods of communicating those changes
- Contributed to two ETSAB reports: Safety and Security on Transit, and Advertising

PEOPLE WITH DISABILITIES POLICY C602

Being accessible is more than just having wheelchair access. Accessibility is about the inclusion of every Edmontonian and elimination of barriers that could prevent them from participating in the city.

The City of Edmonton's Accessibility for People with Disabilities Policy C602 was approved by City Council on September 24, 2019. This policy now gives clear direction on the next steps the City must take so all Edmontonians have equal access to participate in the city.

The Accessibility Advisory Committee (AAC) worked closely with City Administration throughout the development of the policy and are currently involved with the policy implementation. Members have been involved in designing and participating in public engagement activities and have reviewed plans at each stage along the way.

We will continue to engage with City Administration and liaise with the disability community to ensure the City is making incremental changes and improvements to everything we do to address barriers to accessibility, ensuring a better life for all Edmontonians.

The Accessibility Advisory Committee looks forward to seeing the Corporate Accessibility Plan come to reality in 2021.





COVID-19 AND THE AAC

The AAC were concerned about Edmontonians and accessibility while COVID-19 was occurring. Here are some examples of how AAC members ensured Edmonton and beyond was looking at accessibility and inclusion for all.

Crystal Jones, AAC Member, sent a Letter to Mr. Tyler Shandro (Alberta Minister of Health) and Dr. Deena Hinshaw (Alberta Chief Medical Health Officer) regarding concerns that COVID-19 messages and announcements were not reaching the deaf community. In response, starting March 16, 2021, an American Sign Language (ASL) interpreter was present during Provincial COVID-19 briefings. The City of Edmonton is also now providing ASL services at its public briefings.

The AAC wrote a letter addressed to Ms. Rajan Sawhney MLA, UCP and cc'd Ms. Marie Renaud MLA, NDP in regards to the UCP governments proposed changes from public sector care to private sector care for individuals with developmental disabilities. The AAC asked that the Provincial Government reconsider this move, and also expressed concern about the lack of consultations and

emphasising the importance of thorough and adequate consultations. The timing of this change was during the COVID-19 pandemic and posed a greater risk to the health and safety of the individuals and families impacted by this decision. The letter was tabled in the legislature.

On September 14, 2020, Jason Pisesky and Tonia LaRiviere went to the City Council public hearing to express concerns regarding the lack of inclusion of accessibility items in its current City Plan draft. A 15 page comprehensive report was put together highlighting the concerns and suggestions that were submitted to City administration and City Council. The main concerns were regarding accessible housing and transit (specifically a need to add mention of the para-transit network).





National AccessAbility Week (NAAW) 2019

National AccessAbility Week celebrates the contributions of people with disabilities and functional impairments. The celebration recognizes the efforts of individuals, communities and workplaces to enhance inclusion by removing barriers. NAAW aims to act as a tool for social change by creating conversations around the issues of education, transportation, housing, employment and recreation across the Country.

Events were planned throughout the week of May 28th to June 3rd to celebrate and recognize the efforts of individuals and groups making our communities more welcoming and accessible.

May 28th The ADHD Project

Award-winning storyteller Carlyn Rhamey shares the trials and triumphs of growing up a little bit “special” and embracing what makes us different; a hilariously honest journey exploring ADHD and celebrating neurodiversity. Enter Carlyn’s world of chaos, creativity, and combat with her mind in this one-hour theatrical production.

June 1st Accessible Home Tours

The AAC's home tours continued in 2019 with great success. Over 100 Edmontonians had the opportunity to explore the homes and features of two accessible homes in Edmonton. Key accessible design strategies we featured included no-step entrances at the front door, elevators to make vertical access accessible, and wet room designs for the bathroom areas

Our aim was to bring together city officials, builders, and citizens to explore what currently exists in accessible housing and to imagine how some of these features could be incorporated into standard building practice. We hope to grow these tours in the future.

June 3rd **Live with Heart, Lowell** **and Julie Taylor**

In this motivational presentation, Julie and Lowell Taylor discuss Lowell's visual impairment and how their positivity, teamwork and love help turn obstacles into opportunities. Lowell was the first blind contestant on The Amazing Race, and now his sights are set on competing in the Tokyo 2020 Paralympic Games in Road and Track Cycling. Together they share their life stories and the challenges of going blind, living with a blind husband, and the support needed along the way. They prove that positivity can outshine a disability – that negativity can be more debilitating than a disability.

City Council Luncheon

The AAC held the City Council luncheon on February 21, 2019. The AAC invited Mayor Iveson, City Councillors and the Executive Leadership Team to its annual luncheon in the Heritage room at City Hall. A short presentation and quiz game highlighted 2019 AAC successes. AAC members and Council spent their time discussing these and other issues of accessibility. It was also an opportunity to get to know each other in an informal setting.

Mayor's Awards

The 2019 Mayor's Awards took place on May 9, 2019 at City Hall. There were nineteen nominees in total from which six winners across all categories were chosen.
