HVAC and Gas Permit Changes to Support Remote Video Inspection

With the transition to video-based inspections, changes to permit application requirements are being made to support efficient review and inspection of furnace replacements, basement developments, and new gas appliances. Documentation for heating and ventilation and gas permits that was previously collected at the time of physical inspection is now required to be provided by the applicant at time of permit application. Learn more.

New Residential Utility Service Installation Guide

To enhance customer service and ensure safe and quality installations of utility services, the City has collaborated with CHBA, ATCO, EPCOR, the Inspections Group and Edmonton-based Underground Contractors to produce a standardized installation guide. These new guidelines will come into effect on January 1, 2021 but contractors may begin using them immediately. **View the guide.**

Lot Grading Refund Changes

As of December 1, 2020, the following administrative fees will be applied to lot grading fee refunds.

- Where a decision has been made on a Lot Grading Plan, refunds of the lot grading fee will not be granted.
- Where a Lot Grading Plan has been processed, 20% of the lot grading fee will be retained for administration costs;
- Where a Lot Grading Plan has not been processed, a full refund of the lot grading fee will be granted

This change recognizes the services provided by the City and aligns with other fee refund practices.
