BYLAW NO. 9957

Being a Bylaw to Establish the City of Edmonton Access Control Bylaw

WHEREAS Section 26 of the <u>City Transportation Act</u>, R.S.A. 1980, Chapter C-10, empowers the City Council to pass bylaws dealing with the control of access to the transportation system of the municipality;

AND WHEREAS the aforesaid Section 26 in part reads as follows:

- "26(1) Notwithstanding any other Act, a City may by bylaw at any time close
 - (a) any street providing access to or from a controlled street, or
 - (b) any means of access between a controlled street and land adjacent to a controlled street."

AND WHEREAS the Municipal Council of the City of Edmonton finds it desirable to pass a Bylaw pursuant to the said provisions of the said <u>City Transportation Act</u>;

NOW THEREFORE, the Municipal Council of the City of Edmonton, duly assembled, hereby enacts as follows:

- 1. This Bylaw may be cited as "The City of Edmonton Access Control Bylaw".
- 2. The means of access to a controlled street is closed at the locations specified in Schedule I attached hereto and forming part of this Bylaw.
