Heritage Planners Report Edmonton Historical Board June 26, 2013

- The Designation Bylaw to designate the Kelly Ramsay Building was passed by City Council on June 19th. Dismantling of the two facades has begun.
- The Notice to Designate the Rossdale Brewery was passed by City Council on February 16th. Designation Bylaw will go forward in August the same time as the re-zoning application.
- The Bylaw to Designate the Marshall McLuhan Residence is scheduled for City Council on July 17th.
- Bylaw to Designate the J.J. Duggan House (the offices of the Alberta Association of Architects) was passed by City Council on May 22, 2013.
- Notices of Intention to designate the First Presbyterian Church and Knox Church as well as the A.K Buckham and Humphreys Residences have been passed by Executive Committee on Monday June 24th. They next go to City Council on July 3ed. Designation Bylaws will be scheduled for the last Council meeting on September 18th, before the election begins.
- Development on the Molson's Brewery site is still on the horizon. The new owners have submitted an application to re-zone the property. We are seeing some conceptual plans for the site. At the moment the owners are not expressing interest in having the two buildings designated.
- Our Report on Church Street as a potential Historic Area was presented to Executive Committee on April 29th. They have told us to proceed with the short term goals, and asked that we go back in August with a report on the implications of doing a DC1 zone for the area to recognize it as a historic area.
- We have a Young Canada Works grant to hire an intern heritage planner, but we have experienced delays with our HR department. As we now require to hire the intern under our union CSU 52. The position can no longer be "out of scope". We hope to have the student on board in August. Meanwhile we are sharing a summer student with Urban Design group.
- Reminder that our book, *Building a Legacy* by Ken TIngley is now available at Audrey's Books or at the store at Tix on The Square.
