A By-Law to further amend By-Law No 195 (the Public Health By-Law)

The Municipal Council of the City of Edmonton duly assembled enacts as follows:-

- 1. By-Law No 195 passed by the Town of Edmonton intituthed "a By-Law respecting the Public Health" is hereby further amended by adding to Section 12 (a) added to the said By-Law No 195 by By-Law No 99 passed by the City of Edmonton the following sub-section that is to say:-
- (d) No person shall occupy as a dwelling place a Tent or building apparently intended as a temperary building unless there shall have been issued in respectof such tent or building, a License under this By-Law nor unless there shall be continuously exposed upon a conspicuous part of such tent or building a tag or plate on which appears in legible and conspicuous figures the number of the tent or building as designated in the License, and the letters "B.H." indicating that the said tag or plate has been issued under the authority of the Board of Health of the City of Edmonton.
- (e) Licenses for the Purpose of this By-Law shall be issued by the Secretary-Treasurer of the City upon receiving the certificate of the Medical Health Officer that the tent or building in respect of which a License is asked and the premises used in connection therewith conform to the Public Health Act and the By-Laws and regulations respecting the Public Health in force within the City for the time being and upon payment of the sum of one Dollar (\$1.)

- (f) Every License issued under the provisions of this
 By-Law shall run from the date of the issue thereof untill
 the 31st December next thereafter.
- (g) Every License shall be issued in duplicate, one copy being retained by the Secretary Treasurer and transmitted by him to the Medical Health Officer; the other copy being delivered to the licensee.
- (h) Licenses may be transfered from the Licensee to any person who intends to use in the future the tent or tents. building or buildings comprised therein on payment to the Secretary Treasurer of the sum of 25% and upon production of a certificate to the effect set forth in the foregoing clause (e)
- (i) A license under this By-Law may be taken cut in the name of any person who occupies or uses the tent or tents or building or buildings to be comprised therein whether he be the owner thereof or not and not more than one license shall be required in respect of any tent or building.
- (j) The Licensee shall be responsible that the tent or tents, building or buildings and the premises used in connection therewith are kept so as to conform to the Public Health act and the By-Law and regulations for the time being in force respecting the Public Health and in default thereof shall be subject to the penalties of the said By-Law No.195.
- (k) The premises comprised in any license issued under this By-Law shall be subject to inspection at all reasonable times by the Medical Health Officer or any acting on his behalf.

(1) The prvisions of this By-Law shall not extend to a tent or building used solely for th purpose of affording additional sleeping accommodation only for the Bona fide occupants of an adjacent residence.
