Motion of support with the following conditions:

• The applicant investigates sustainable initiatives within the project (i.e. green roofs, solar photo-voltaeic panels, low impact development).

- The applicant examines the project in the context of the greater Metro Line design. Specifically, the applicant investigates a potential mutable kit of parts (i.e. design standards) that can provide both consistency and adaptation to specific sites and the broader community contexts.
- The applicant further builds on the aspects of each character zone, existing and proposed, along the alignment of the Metro Line. This can be expressed through various urban design components, such as materials, planting, furnishings and features.
- The applicant ensures winter and cold weather protection is incorporated into the design of this and future stations and elements.
- The applicant continues to integrate access design guidelines (i.e. paving, lighting, materiality). These interfaces need to better negotiate between the varied users including pedestrians, cyclists and motorists.
