Motion of support with conditions

The Committee encourages the Applicant to:

- Implement additional architectural design and landscape strategies along the east property line / elevation (i.e. windows, articulation, detail, planting) to improve the pedestrian experience along, and visibility from, 109th street.
- Refine the front entry design to integrate and enhance the interfaces with the streetscape, adjacent properties and the larger neighbourhood. Strategies

could include increased articulation, weather protection at the doorway, building and site lighting, etc.

- Refine planting design along the front elevation to ensure the basement window receives sufficient natural light.
- Explore opportunities to expand greenspace / amenity opportunities in the front and rear yard, and limit impervious surfaces in the rear yard.

The Committee also notes that the project could have benefitted from an Informal Pre-Consultation.
