## The Committee recommends the following:

- Ensuring the outdoor daycare space maximizes visibility, and that the design and materiality of the enclosure is harmonious with the building architecture.
- Exploring year-round programming of the terrace, and the incorporation of high quality finishes and materials in the space (eg. soffit panel) which are harmonious with the building and extend the interior design into the landscape.
- Giving additional consideration to streetscape development as well as the plaza at the SE corner of the building, to enhance the pedestrian environment, encourage activation and define key entrances / exits to the building.
- Giving further consideration of how street level programming can maximize opportunities to animate 97 street at all hours. In addition, stronger definition of the main building entrance off 97 Street is needed.
- Improving the urban condition and interface of the district energy centre with 102A Avenue both the north facade and the street-level interface. The Committee understands that this component of the proposal is part of Phase 2; and the Committee therefore recommends that this second phase be reviewed by EDC at the appropriate time.
