Motion of Support with Conditions

While the Committee supports the project, there are several items which could benefit from additional design consideration/refinement:

- Inconsistencies in EDC package and presentation with respect to the east elevation were noted. The Committee feels the elevations in the presentation better represent the depth and articulation that is required for the primary building elevation.
- The Applicant should provide further detail with respect to the roof drainage strategy to ensure it does not have a negative impact on the site plan.
- The Applicant should reassess and address the frontage with respect to landscape and amenities to better enhance the building frontage and support and enhance streetscape integration, activity and animation (e.g., bike racks, benches, etc.). Specific areas of concern include:
 - Walkway transition from the City sidewalk (ramping does not appear to be required);
 - Location and orientation of bike racks and seating
 - Extent of washed rock being proposed especially on City of Edmonton property; and
 - Location, arrangement and type of plant species.
