About the First Place Program

The First Place Program defers homeowners' cost of land, allowing them to repay this cost to the City after five years, which lowers their mortgage payments.

The homes are market-priced and built in established neighbourhoods by the City's professional build partners, Rohit Communities and Landmark Homes.

The program is City Council approved.



 Community preferences about the site location options


Technical Feasibility

First Place Program 'Split' Building Site: Option 1



Features

- + Townhouse units are in two areas (Lots A and C).
- Two development locations results in higher construction disturbance to community.
- + Less overall impact to the more frequently booked sports fields.
- Temporary soccer field 5 and temporary diamond teaching station 4 will not be replaced.
- + Park access remains, but is reduced, from both Millbourne Road and 76 Street.

First Place Program 'Consolidated' Building Site: Option 2



Features

- + Townhouse units are consolidated in one area
- Single consolidated site is results in lower construction disturbance to community.
- Soccer field 1, soccer field 2, and baseball diamond 2 will be removed but may be replaced if necessary. Replacement of removed fields will be determined by a needs assessment and available funding.
- Park access remains from Millbourne Road.
 Park access from 76 Street is limited.
- Community support is required for Option 2
 'Consolidated' site to be selected.
