A Bylaw to establish a committee to recommend names for public places or objects.

WHEREAS it is deemed desirable that a committee be formed to act in an advisory capacity to Council in establishing suitable names for *neighborhood unit areas,* subdivisions, highways, parks or other public places and also public buildings or structures; and

WHEREAS the general public and the School Boards of the City as well as certain utility Departments are affected by the choice of names and it is considered desirable that the committee comprise representatives of these groups.

NOW THEREFORE the Municipal Council of The City of Edmonton duly assembled, enacts as follows:

Committee name and objects.

1. A committee to be known as the "District Names Advisory Committee" is hereby established for the purpose of suggesting to City Council the most appropriate names to be given to the following:

- (i) Parks, playgrounds and other public places;
- (ii) New subdivisions and revisions of existing subdivisions; *and neighborhood unit areas;*
- (iii) Public buildings;
- (iv) Public structures such as bridges;
- (v) Scenic driveways or other highways;
- (vi) Public places generally.

Composition of Committee

2. (a) The committee shall comprise the following:
- (1) One alderman of the City;
 - (2) A member of the Edmonton Public School Board;
 - (3) A member of the Edmonton Separate School Board;
 - (4) The Chairman of the Archives and Landmarks Committee;
 - (5) A nominee of the Federation of Community Leagues.
 - (6) ~~The City Engineer or his designated alternative representative;~~

(5) ~~(6)~~ The Town Planner or his designated alternative representative;

Committee Secretary

(b) The permanent secretary of the said committee shall be the member of the Town Planning Department known as the Street Addressing Co-ordinator whose duty it is to arrange the allotment of numbers to new buildings within the City and he shall keep records of meetings of the District Names Advisory Committee and when so directed by the committee shall communicate its recommendations to City Council.

Committee's 3.

(a) Members appointed shall hold office for a period of two

(b) All appointments to the committee shall be reported to and confirmed by Council;

(c) All members shall remain in office until their respective successors are appointed;

(d) Retiring members shall be eligible for re-appointment, *irrespective of the number of terms served.*

(e) In the event of a vacancy occurring, the person appointed to fill such vacancy shall hold office for the remainder of the unexpired term of his predecessor;

(f) All persons appointed members of the committee shall be residents of The City of Edmonton and shall remain members only while continuing to be residents of the City;

(g) Any members of the committee may resign therefrom at any time by sending written notice to the City Clerk of The City of Edmonton and such resignation shall take effect on the date therein stated, or where no date is stated, then upon the date when the resignation was received by the City Clerk, and any member of the committee may be removed for cause by the Council of the City at any time;

(h) The chairman of the Committee shall be chosen by the members at the first meeting thereof, which shall take place within one month from the date of the passing of this bylaw;

(i) Regular meetings of the committee shall be held at least once every three months in the Civic Block, Edmonton, or elsewhere within the City at the discretion of the committee, the time and place of such regular meeting to be determined by the committee at its first meeting, subject always to the right of the committee to change the time and place when desirable;

(j) Special meetings may be called on 24 hours' notice by the chairman or at the request of two or more members of the committee;

(k) A quorum of the committee shall be three committee members exclusive of the Secretary;

(l) The chairman shall have a vote on any question and in the event of a tie the motion shall be lost;

- (p) (m) The committee may appoint sub-committees, not limited in personnel to members of the District Names Advisory Committee, in order to deal with any special phases of any matters included in the duties of the committee.
- (B) 4. The committee may hear and consider representations from any citizen or from any group of citizens upon any matter relating to the objects of the committee.
- (R) 5. Council may at any time seek the opinion of the committee as to the most desirable name for any public place or object and the Commissioners may refer to the committee any similar matter.
- (S) 6. Any member of the committee may place a matter upon the agenda of the committee by writing to the Secretary and if the matter is later recommended to City Council the Committee Secretary shall indicate the number of the committee present and voting upon the motion and also how many votes were in the affirmative and how many in the negative.
