BYLAW NO. 1121

A Bylaw to establish a voluntary Archives Committee to be known as "The City of Edmonton Archives Committee" and to define its composition, powers and duties.

WHEREAS there is now available in the City of Edmonton considerable valuable data concerning the historical past of The City of Edmonton and the vicinity; and

WHEREAS it is deemed expedient to establish a voluntary committee to act in an advisory capacity to Council in order that the historical data may be collected, indexed and preserved.

NOW THEREFORE the Municipal Council of The City of Edmonton, duly assembled, enacts as follows:-

- Establishnent of
 Archives City of Edmonton Archives Committee" is hereby established;
 Committee.
 - (b) The Archives Committee shall consist of not more than eight members to be appointed from time to time by resolution of Council;
 - (c) Not later than the 1st day of March, 1947, the City Council shall appoint not exceeding eight persons as members of the Committee, one-half of whom shall hold office until the 31st day of December, 1947, and the other half to hold office until the 31st day of December, 1948; the members appointed to vacancies arising from and after the 31st day of December, 1947, shall hold office for a period of two years;
 - (d) All members shall remain in office until their respective successors are appointed;
 - (e) Retiring members shall be eligible for reappointment;
 - (f) In the event of a vacancy occurring, the person appointed to fill such vacancy shall hold office for the remainder of the unexpired term of his predecessor;

- (g) All persons appointed members of the Committee shall be residents of The City of Edmonton and shall remain members only while continuing to be residents of the City;
- (h) Any members of the Committee may resign therefrom at any time by sending written notice to the City Clerk
 of The City of Edmonton and such resignation shall take effect
 on the date therein stated, or where no date is stated, then
 upon the date when the resignation was received by the City
 Clerk, and any member of the Committee may be removed for
 cause by the Council of the City at any time;
- (i) The chairman of the Committee shall be chosen by the members at the first meeting thereof, which shall take place within one month from the date of the passing of this bylaw;
- (j) Regular meetings of the Committee shall be held at least once every three months in the Civic Block, Edmonton, or elsewhere within the City at the discretion of the Committee, the time and place of such regular meeting to be determined by the Committee at its first meeting, subject always to the right of the Committee to change the time and place when desirable:
- (k) Special meetings may be called on 24 hours' notice by the chairman or at the request of two or more members of the Committee;
- (1) A quorum of the Committee shall be three Committee members:
- (m) The chairman shall have a vote on any question and in the event of a tie the motion shall be lost;
- (n) The Committee may appoint sub-committees, not limited in personel to members of the Archives Committee, in order to deal with any special phases of any matters included in the duties of the Committee.

Duties and

- 2. The Committee shall act in an advisory capacity to powers of Committee. the City Council in order to discover, select, index, catalogue and prepare for safe keeping, reference and suitable display at such a location within the City as may be directed by the Council, all books, charts, maps, papers, photographs, paintings, property, chattels or objects of any description relating to the history, alteration and development of The City of Edmonton, and to obtain such other similar information as the Council may require.
 - 3. The Committee shall have power to recommend to the City Council the purchase of any property, real or personal, or any historical matter and may recommend the employment of one or more persons to collect and catalogue the information received and prepare it for public inspection.
 - The Committee may recommend to the Council the most suitable method of housing and displaying the historical matter collected by the Archives Committee.
 - 5. The Committee shall make such other recommendations as it deems desirable in the carrying out of its duties and may request Council from time to time to make money grants or authorize expenditures necessarily incidental to the work of the Committee.
 - 5. The Committee may hear and consider representations from any citizen or any group of citizens on any matter relating to the work of the Archives Committee.
 - 7. In December of each year the Committee shall present to City Council in writing an annual report upon the work and activities of the Committee.

8. Neither the said Committee nor any member thereof shall have any power to pledge the credit of the City in connection with anymatters nor shall the said Committee nor any members thereof have any power to authorize any expenditure to be charged against The City of Edmonton.
